In view of the continued increase in operational and administrative costs associated with delivering services, supporting industry initiatives, the matter of revising the membership subscription fees was placed before the **381st Committee of Administration (CoA) Meeting**. After due consideration, it has been decided by the COA Members to revise the membership subscription structure with effect from **1st April 2026**. Please note that this revision has been undertaken after a gap of 8 years, during which the subscription rates had remained unchanged. The revised fee structure and documentation requirements for each membership category are detailed below:
