**Space Rental Cost:**

- Minimum size for Package Stand: 9 sqm
- Minimum size for Indoor Raw Space: 36 sqm
- Package stands below 18 sqm are not eligible for booth design upgrades.

**Double Deck Construction:**

Only raw space with an area of 100 sqm or above is eligible for double deck booth design. The construction area of the 2nd level (excluding the area of any staircase) should not exceed 30% of its ground level area, and should be at least 30 sqm and not exceeding 160 sqm.

**DISCOUNT SCHEMES:**

**Payment Terms Based on Contract Execution Date**

- Booth rental payment shall be settled by **13 October 2026** to enjoy the Early Payment Discount.
- For contracts dated between **13 October 2026 and 13 January 2027 (inclusive)**, payment shall be made within **2 weeks from the contract date**.
- For contracts dated **after 13 January 2027**, payment shall be made within **1 week** from the contract date.
