**Subject: URGENT: Request for Inputs on AITIGA 1st Review: Consideration of seeking concession from ASEAN and liberalization of T/Ls of India under the 1st Review of the ASEAN-India Trade in Goods agreement (AITIGA)**

Dear Members,

The Department of Commerce has shared a list of **102 tariff lines (TLs)** and requested stakeholder inputs regarding their possible further liberalization/elimination under the ongoing review of the **ASEAN-India Trade in Goods Agreement (AITIGA)**.

As part of its preliminary assessment, the Department has analyzed these tariff lines based on specified Criteria 1 and Criteria 2. The analysis indicates that:

- **30 tariff lines under Criteria 1** and **72 tariff lines under Criteria 2** do not appear significantly sensitive from an India–ASEAN trade perspective.
- India is a **net exporter** in these tariff lines, while both **ASEAN and China are net importers**.
- These tariff lines have already been liberalized under at least **two of India's existing FTAs**.
- For a subset of these tariff lines, **China's share in ASEAN imports is also relatively low**.

In view of the above, the Department of Commerce and DCPC has sought industry feedback on the proposed **further tariff liberalization/elimination of these 102 tariff lines under the AITIGA Review**.

Members are requested to examine the attached list and provide their comments, concerns, or recommendations at the earliest to enable Plexconcil to submit a consolidated industry response to the Government.
