**Subject: Amendments to the Guidelines for Trade Regulations, Accreditation and Compliance Enablement under Export Promotion Mission (EPM) - Niryat Disha.**

This is to inform you that the Directorate General of Foreign Trade has issued **Trade Notice No. 09/2026-27 dated 01st July 2026**, in continuation of Trade Notice No. 26/2025-26 dated 20th February 2026 introducing amendments to the Guidelines for Trade Regulations, Accreditation and Compliance Enablement (TRACE) under the Export Promotion Mission (EPM) - Niryat Disha.

**Key Highlights of the Amendments:**

- **Dynamic List** – Certifications list (Annexure-I in this trade notice) now dynamic, reviewed periodically.
- **MSME Support** – Micro & Small: Up to 95% of the actual cost (net of applicable taxes, duties, and cess) or the notified ceiling, whichever is lower Medium: Up to 80% of the actual cost (net of applicable taxes, duties, and cess) or the notified ceiling, whichever is lower.
- **Disbursement** – Two instalments: 50% after certification, 50% after exports.
- **Reimbursement Claims** – Filed in two stages (RC-1 after certification, RC-2 after exports). Evidence of exports must be submitted within 2 years; else claims lapse and recovery may apply.
- **Governance** – Sub-Committee to oversee ceilings and certification list update

All other provisions of Trade Notice No. 26/2025-26 dated 20th February 2026 remain unchanged.

Members are advised to review the updated guidelines carefully in the official trade notice and align their compliance and certification processes accordingly.
