विषय: भारत-ईएफटीए टीईपीए का कार्यान्वयन

आपको सूचित किया जाता है कि भारत-यूरोपीय मुक्त व्यापार संघ (ईएफटीए) व्यापार और आर्थिक भागीदारी समझौता (टीईपीए) 1 अक्टूबर 2025 से लागू हो गया है।

टीईपीए एक आधुनिक और महत्वाकांक्षी समझौता है जिस पर 10 मार्च 2024 को नई दिल्ली में हस्ताक्षर किए गए थे। भारत द्वारा हस्ताक्षरित किसी भी मुक्त व्यापार समझौते (एफटीए) में पहली बार, टीईपीए में निवेश और रोजगार सृजन की प्रतिबद्धता शामिल है।

ईएफटीए, यूरोपीय संघ और ब्रिटेन के अलावा, यूरोप का एक प्रमुख आर्थिक समूह है। ईएफटीए देशों में, स्विट्जरलैंड भारत का सबसे बड़ा व्यापारिक साझेदार है, उसके बाद नॉर्वे का स्थान है। टीईपीए, विशिष्ट इनपुट तक पहुँच प्रदान करके भारत के निर्यातकों को सशक्त बनाएगा और अनुकूल व्यापार एवं निवेश वातावरण तैयार करेगा।

Annexure: Key Gains Expected under India-EFTA TEPA

The annual import of plastic products by the EFTA countries (Iceland, Norway, and Switzerland) * is USD 17.97 billion, of which India supplies hardly USD 55.8 million or 0.3%. Considering India's export capacity, there is USD 8.02 billion worth untapped export potential to EFTA countries. Switzerland, Norway and Iceland have given duty-free market access for most of the Indian plastic goods under the India-EFTA TEPA. Therefore, there is scope for Indian exporters to grow their presence in the EFTA market, especially for goods with untapped export potential.

Maximum export potential is in plastic raw materials (USD 1.65 billion), followed by Consumer & Houseware products (USD 1.4 billion), Plastic films & sheets (USD 1.3 billion) and Medical items of plastics (USD 1.2) billion. India has hardly 0.1% - 0.2% market share in these products in EFTA countries, which implies untapped export potential.

HS Code-wise Potential products

India has USD 8.02 billion worth untapped export potential to EFTA countries; Of these, there are 93 products (at 6-digit HS code) where export potential is more than USD 10 million. Some of these top products are: Needles & Canulae, Medical Instruments & Appliances, Plates & Sheets, Switches, Sacs & Bags, Packaging Articles, Handbags and so on.
