Respected Sir,

Greetings from THE PLASTICS EXPORT PROMOTION COUNCIL!

We thank you for issuing PN no 47 dated 7th December, 2019 regarding Changes in MEIS rate by way of granting 2% additional MEIS.

We wish to inform you that MEIS on Flexible Intermediate bulk containers (FIBCs) falling under HSN Code 63053200 was introduced vide Public Notice no.44 dated 29.10.2015 @ 2% for some selected countries initially and then amended vide Public Notice no.61 dated 07.03.2017 to cover all countries. Meanwhile the Government announced an additional MEIS of 2% on various products vide below public notices from time to time: -

Public Notice No. 42 dated 24.11.2017, Public Notice No. 44 dated 5.12.2017, Public Notice No. 2 dated 1.5.2018, Public Notice No. 13 dated 12.6.2018, and Public Notice No. 28 dated 08.08.2018.

Please note that FIBCs were covered vide Public Notice no.42 dated 24.1.2017 and its amendment PN no 61 dtd 07.03.2017.

Sir, we wish to bring to your notice that after a lapse of four months while PN no 47 dated 7th December, 2019 has been issued granting much needed relief to many affected Industries but the FIBC Industry continues to suffer and they are badly affected by exclusion of their products from the list.

We wish to further inform that w.e.f. 01.08.2019, FIBC industries neither getting MEIS @ 2% or additionally allowed 2% nor the product under HS Code 63053200 (FIBC) is covered in the new RoSCTL scheme.

We believe this is an inadvertent error. We request you kindly look into this matter and grant them MEIS as applicable to other industries retrospectively i.e from 01.08.2019.

We have already taken up this matter with DoC (EPCAP Division) and Doc vide their letter dated 18.11.2019 has already recommended to your good office for favorable consideration.

We request your kind attention in this matter.
