Articles 27.1

27.1 Chairman's term of office

The Chairman shall hold office for a period of two years and:

- (a) shall retire accordingly; and
- (b) shall not be eligible for re-election at the subsequent two elections.

27.2 Vice-Chairman of the Committee.

- (a) There shall be one Vice-Chairman who shall be elected by the Committee for a term of two years.
- (b) On completion of his term of two years, Vice-Chairman shall be endorsed by the Committee to succeed the Chairman unless he is unwilling to accept Chairmanship or he has incurred any of the disqualifications enumerated in article 8.1 regard to membership of the Council
- (c) shall not be eligible for re-election at the subsequent two elections.

FURTHER RESOLVED THAT the Committee be and is hereby authorised to take all actions and to do all acts and deeds as may be required for the purpose.

5. To amend the provisions of clause no 36.3 of the Articles of Association

To consider and if thought fit, to pass with or without modification(s) the following resolution as a Special Resolution:

RESOLVED THAT pursuant to section 14 and other applicable provisions of the Companies Act 2013 in the Article no 36.3 a new para as under be added after the existing para :-

Any member entitled to vote may vote by conventional means, or by means of the Internet or other electronic means. 1. Review of Export Performance

The export analysis shown in Table 2 indicates that growth in 2014-2015 was negative at 3.03% implying exports of 7.7 billion US Dollars. The plastic raw materials constituted about 33% (reduced by about 6% compared to the same period last year) of the total plastics exports with a substantial negative growth of about 17%. The growth registered by value-added items was about 9.4% which is encouraging given the adverse economic scenario still continuing. The share of the value-added items has also increased which is an encouraging trend. Most value-added items exhibited encouraging growth rates. The direction of exports is shown in Table 2 and achievements are generally good for value-added items. The negative growth rates are generally observed in countries which import more of raw materials..

2. **PARTICIPATION IN INTERNATIONAL TRADE FAIRS/EXHIBITIONS**

2.1 **Chinaplas 2014 - Shanghai, China – April 23-26, 2014**

Chinaplas 2014 is the 28th International Exhibition on Plastics and Rubber Industries. This event is recognized as Asia's No.1 and the World's No.2 largest showcase for the Plastic and Rubber sectors. Chinaplas 2014 covered an area 2,30,000sqm with 3067 exhibitors and more than 1,30,370 visitors. The Council, which is also the exclusive representative of Chinaplas in India, organized Indian participation in this event.

The Buyer – Seller Meet (BSM) took place on 2nd March, 2015 at the Conference Hall of the Auckland Chamber of Commerce at 100 Mayoral Drive, Auckland 101, New Zealand. The BSM was preceded by a briefing by Ms. Smitha Shanbhag, again at the Chamber's premises, where she gave a brief overview of the Chamber's activities, and the overall economic situation of New Zealand, with particular reference to Auckland, regarded as the financial capital of New Zealand.

This was an opportunity for some segments in the plastic sector such as PVC Pipes, tubes and hoses, and members of our delegation from this sector M/s Zenith Plastic Industries, Mumbai & M/s Apex Irrigation, Rajkot were encouraged to make full use of this opportunity. The other issue highlighted was the reconstruction activity in Christchurch which was badly damaged by earthquakes, and the heavy investments being made by China in New Zealand. The delegation members on their part were interested to know about the formalities required to set up a Joint Venture/manufacturing unit in New Zealand, availability of industrial land for the same, and the safety and environment measures that need to be followed, since the environment laws in New Zealand were particularly very stringent.

The briefing which lasted for about an hour, was followed by the BSM at the Conference Hall of the Chamber where members displayed their products and brochures. The Auckland Chamber had sent out information to its members about our BSM, and the turnout though relatively low, had some serious buyers turning up for the event, such as Mr. Steve Loveridge, Business Development Manager of M/s Holdfast NZ Ltd., who drove all the way from Hamilton to attend this event. 4.2 **Seminar on “Salient Features and benefits of Free Trade Agreements” and the “Advantages of Solar Energy as an additional source of power” – Chennai – June 20, 2014**

The Chennai office, organized an export promotion Seminar on “Salient Features and benefits of Free Trade Agreements” and the “Advantages of Solar Energy as an additional source of power” on Friday, June 20, 2014, at the Residency Towers Hotel in Chennai. 4.3 Export Seminar – New Delhi – August 8, 2014

5. OTHER MEETINGS

5.1. Meeting on formulation of Foreign Trade Policy 2014 – 19 – Udyog Bhawan, New Delhi – 9th April, 2014

The meeting was chaired by Mr. D.K.Singh, Additional Director General of Foreign Trade.

The Council was requested to make a presentation indicating the data in major items of export and potential markets. In addition, the Council was also requested to identify some high potential items from a list of important tariff lines forwarded by DGFT as a result of an internal exercise carried out by them.

Mr. Sanjiv R. Dewan, Regional Director made the presentation as requested by DGFT, and also submitted a list of some of the high potential items. Mr. G.Sudhakar, Chairman and Mr. Manish Khetan, Director Manish Vinyls and our member exporter of PVC Leather Cloth, attended the meeting. The Chairman spoke about the huge potential of the Human Hair sector, while Mr. Manish Khetan raised the issue regarding the difficulty in redemption of Advance License in view of the one to one correlation between the Bill of entry and the Shipping Bill that was being insisted upon, as per a recent notification issued by DGFT.

5.2. Workshop on Customs, Excise and Service Tax – Chennai – April 09, 2014

A one-day workshop on Customs, Excise and Service Tax related to exports was organized by M/s FIEO, jointly with National Academy of Customs Excise & Narcotics, an apex Government of India Institute for capacity building in the field of indirect taxation. The workshop sessions covered latest changes in Foreign Trade Policy, Export Promotion Incentive Schemes, Customs and Central Excise rules and procedures etc, and was followed by an open house with senior officials from the Customs (Sea & Air), Central Excise and Service Tax Departments. Mr P.R. Subramanian, Assistant Director, participated in the workshop.

5.3. Round Table on 'Leverage Logistics in The Netherlands to build European Markets' – Chennai – April 11, 2014

A Round Table to 'Leverage Logistics in The Netherlands to build European Markets' by designing an effective supply-chain to become more competitive in the European market was organized by the Madras Chamber of Commerce & Industry jointly with The Netherlands Foreign Investment Agency (NFIA). Mrs. Gerdalies van Diggelen, Executive Director, NFIA India, said that the Netherlands was considered as an ideal gateway to European markets. She briefed participants about the advantages the Netherlands offered, in terms of the excellent and extensive connectivity with the rest of the world through an extensive network of road, rail, short sea and inland waterways with the rest of Europe, and encouraged Indian companies to set up a presence in the Netherlands, just as many international companies based their pan-European Distribution Centres in the Netherlands. Mr Mathijs Benink, International Distribution Council said that the Netherlands also offers a highly competitive fiscal climate for indirect and direct taxes as well as a possibility of a VAT deferment for imports into the EU which would result in cash flow advantages, and also highlighted what the Rotterdam Region offers to companies distributing their goods in Europe. Mr Jaswanth Soundarapandian, Regional Director, participated in the roundtable.

5.4. Launch Function/Roadshow of PLASTINDIA 2015 – Chennai – May 06, 2014

The launch function / roadshow of the PlastIndia 2015 – the 9th International Plastics Exhibition and Conference, was held at the Le Royal Meridien Hotel, Chennai. Mr J.R. Shah, Chairman (National Executive Council), PlastIndia 2015, welcomed the participants and exhorted industry entrepreneurs to exhibit and showcase their products in this prestigious event that was being organized from February 05-10, 2015 in New Delhi (later shifted to Gandhinagar, Gujarat). Mr K. Dhanavel, IAS, Secretary to the

Government of Tamil Nadu (MSME Department), the Chief Guest delivered the keynote address. Mr G. Sudhakar, Chairman, Mr Jaswanth Soundarapandian, Regional Director and Mr S. Vijayan, Deputy Director, participated in the launch function.

5.5. Meeting on Website upgradation of Export Promotion Councils by IBEF – Udyog Bhawan – July 25, 2014

A meeting on upgradation of the websites of various Export Promotion Councils was held under the Chairmanship of Mr. Rajeev Arora, Joint Secretary, Department of Commerce.

IBEF presented the issues to be addressed by EPCs for making their website export oriented.

Some of the issues highlighted by IBEF during their presentation with regard to the websites of various EPC's were as below:

- Almost 100% domestic web traffic.
- Design and layout not user friendly
- Event oriented websites
- Font size small. Uncomfortable to read on several websites
- Images are skewed and not in proper sizes.
- Scanned PDFs are uploaded without proper nomenclature.
- Content not updated frequently
- Site map not found
- Poor world ranking and India ranking
- Search function not found on some websites
- Information Architecture (IA) of websites is not user friendly
- Technology and functionality not updated
- Audio Visual content/dynamic content missing
- Social media widgets missing
- URL structure needs to be improved
- Google Analytics is not being used

EPC's were requested to revamp their websites, keeping the above points in mind. IBEF offered to assist the EPC's in this exercise.

Mr. Sanjiv R. Dewan, Regional Director represented our Council at the meeting.

5.6. Meeting on Website upgradation of Export Promotion Councils by IBEF – Udyog Bhawan – July 25, 2014 Panel Discussion on India's Export Growth – Critical Issues – Chennai – August 07, 2014

A panel discussion on India's Export Growth – Critical Issues' was organized by M/s Federation of Indian Export Organizations, jointly with the Business Standard, in association with Andhra Bank. Mr M. Rafeeqe Ahmed, President, FIEO, welcomed the participants and highlighted India's major markets and strategies on the anvil for growth and emphasized the need of drawing up a roadmap to achieve the desired export growth rates in the coming years. Mr C.V. Sankar, IAS, Principal Secretary, Industries & Commerce, Government of Tamil Nadu, delivered the keynote address, and highlighted the role of the State Government in promoting exports. Mr C.V.R. Rajendran, Chairman & Managing Director, Andhra Bank, highlighted on the Trade Finance and related issues and the various support rendered to exporters. Mr S. Vijayan, Deputy Director, participated in the panel discussion.

5.7. Stakeholders Meeting for Pharmaceutical Machinery, Medical Device & Surgical Equipment Panel – Udyog Bhawan, New Delhi – August 22, 2014

EEPC India under the aegis of Ministry of Commerce & Industry, and in coordination with AIMED & IPMMA organised a stakeholders meeting for Pharmaceutical Machinery, Medical Devices & Surgical Equipment. The agenda of the meeting was to discuss the various regulatory issues and challenges being faced by this sector. The meeting was chaired by Mr. Ravi Capoor, Joint Secretary, Department of Commerce.

Some of the major issues discussed were regulatory issues such as the issue of Free Sale Certificate for Medical Devices, not enough attention being paid to this sector and the threat from China. Mr. Ravi Capoor, Joint Secretary, informed that the Department of Commerce proposes to have a separate panel for the Pharmaceutical Machinery & Medical Devices sector and EEPC India would organise participation in the major exhibitions abroad that are held for this sector. Mr. Sanjiv R. Dewan, Regional Director represented our Council at the meeting.

5.8. Meeting with Drawback (DBK) Committee for All Industry Rate (AIR) of duty Drawback for the year 2014-15 – Mumbai – August 13, 2014

Four members DBK Committee was chaired by Dr Saumitra Chaudhuri alongwith Shri. G. K. Pillai (Member), Ms Shobha L. Chary (Member) & Shri Gautam Ray (Member). Council's members who participated were M/s. Garware Wall Ropes Ltd & M/s. Mechemco Industries who represented their issues before the Committee. Mrs Bharti Parave, Senior Executive represented the Council at the above meeting.

5.9. Industry Consultation on Tariff Liberalisation in Regional Comprehensive Economic Partnership (RCEP) – FICCI, New Delhi – October 15, 2014

Ministry of Commerce & Industry, FICCI, PLEXCONCIL, and Centre for WTO Studies organised in cooperation with other partner organisations, an “Industry Consultation on Tariff Liberalization in Regional Comprehensive Economic Partnership (RCEP)”. RCEP or Regional Comprehensive Economic Partnership Agreement [also known as “ASEAN+6” FTA] has been initiated to have a comprehensive FTA among the 10 ASEAN nations (Brunei, Cambodia, Indonesia, Lao PDR, Malaysia, Myanmar, Philippines, Singapore, Thailand and Vietnam) and 6 partner countries namely, China, Japan, South Korea, Australia, New Zealand and India. Once implemented, RCEP will also lead to India’s Free Trade Agreement with China (which does not exist at present) and it’ll have significant implications for Indian business.

The key objectives of the consultation were:

- (i) To identify specific products of India’s export interest [in the RCEP member-countries], in which India could ask for tariff liberalization by RCEP partners.
- (ii) To identify specific products/items in which Indian industry has “defensive interests” or “sensitivity” regarding tariff reduction /elimination by India and consequent liberalization of imports from RCEP countries.
- (iii) To assess and address the non-tariff barriers (NTBs) in RCEP countries.
- (iv) To discuss “rules of origin” issues.

Mr. Sumanta Chaudhuri, Joint Secretary, Ministry of Commerce and Industry, Government of India and other senior officials/experts addressed and interacted with the participants. Plexconcil members from the Northern region, namely M/s Vacmet India Pvt. Ltd., Agra, and M/s RMG Polyvinyl India Limited, New Delhi participated in the industry consultation. Mr. Sanjiv R. Dewan, Regional Director represented Plexconcil at the above meeting and gave inputs for seeking tariff liberalisation for some of the value added plastic items from India to some of the countries under the RCEP.

5.10. Meeting on Export Strategy for Vietnam – Udyog Bhawan, New Delhi – November 14, 2014

The Commerce Secretary chaired a meeting to discuss the Export Strategy for textiles and footwear sector for Vietnam. In addition the following issues were also discussed:

- Top 10 export commodities to Vietnam (viz. Meat and edible meat, fish and crustaceans, iron and steel, cotton, cereals, residues and waste from food industries, coffee, tea, spices, pharmaceutical products, plastics and articles thereof, nuclear reactors, boilers, machinery and mechanical appliances)
- The potential opportunities for enhancing trade and investment cooperation arising from Vietnam’s participation in the Trans – Pacific Partnership Agreement
- Tariff and non – tariff barriers
- Opening of bonded warehouses in Vietnam for cotton and yarn
- Strengthening of Maritime Connectivity
- Participation in country specific industrial parks in Vietnam

Mr. Sanjiv R. Dewan, Regional Director represented Plexconcil at the above meeting.

5.11. Standing Advisory Committee (SAC) meeting of Indian Institute of Packaging – Udyog Bhawan, New Delhi – November 17, 2014

The Department of Commerce, Ministry of Commerce & Industry decided to set up a Standing Advisory Committee(SAC) of the Indian Institute of Packaging with the objective of enhancing the capability of the Trade & Industry to meet the challenge to Indian exports caused by lack of adequate & appropriate packaging. Additional Secretary, Department of Commerce is the Chairman of this Committee, and Director, IIP, the Member Secretary. Heads of all EPC’s, EIA’s and Commodity Boards are the members of the Committee, apart from officials from institutes such as IIT, Mumbai, IIM, Ahmedabad, NID, Ahmedabad etc.

The Committee will examine all issues relating to packaging for Industry and exports, and make suitable recommendations to the Government and IIP, in particular, with regard to:

- (i) Building capacity for provision and dissemination of knowledge relating to modern and appropriate packaging technologies and standards to the Trade & Industry.
- (ii) Analysing regularly the challenges to India’s exports emerging from developments in packaging industry & trade in foreign destinations
- (iii) Analysing, in particular, the developments in trade policy, including tariff and non – tariff barriers, and SPS/technical barriers to trade having impact on the packaging of goods/products exported from India
- (iv) Studying the trends in packaging in major markets such as EU, USA and Japan
- (v) Developing appropriate standards for packaging of identified products in line with the trends in foreign markets and strengthening and establishing a strong capacity in IIP for certification of packaging
- (vi) Setting up, if considered necessary, a Technology Innovation Centre for Packaging in IIP
- (vii) Building capacity and implementing skill development Programmes for packaging industry.

The first meeting of the SAC was held at Udyog Bhawan, New Delhi, under the Chairmanship of Additional Secretary, Department of Commerce, Mr. Rajani Ranjan Rashmi with the following agenda:

1. Opening remarks of the Chairman – SAC, explaining the objectives of the Committee
2. A brief presentation by Director, IIP to highlight the present and proposed activities of the Institute
3. Challenges to India's exports and how improved packaging can help to boost exports

Mr. Sanjiv R. Dewan, Regional Director represented Plexconcil at the above meeting.

5.12. Workshop on Anti-dumping and Countervailing Duty (CVD) Investigations – Chennai – December 19, 2014

A Workshop on 'Anti-dumping and Countervailing Duty (CVD)' was organized by the Federation of Indian Export Organizations (FIEO), jointly with the Centre for WTO Studies, in Chennai. Mr M. Rafeeqe Ahmed, President, FIEO, welcomed the participants. Mr Mukesh Bhatnagar, Professor, Centre for WTO Studies, gave an overview of Trade Remedy Measures and on key provisions on Subsidies Agreement with specific reference to Anti-dumping and CVD Investigations initiated by trading partners which posed several challenges in terms of understanding the legal complexities of the WTO Agreements as well as meeting the onerous information requirements and strict timelines for responding to the investigation questionnaires and interacting with Investigating Authorities of other countries while presenting the legal arguments to defend the interest of Indian exporters. Mr Tapan Mazumder, Director, Department of Commerce, Government of India, spoke on the role of the government in Anti-dumping and CVD Investigations. Mr A.K. Gupta, of M/s TPM Consultants spoke on the CVD Investigations against India, and explained the procedures of US and EU Investigation Authorities. Mr S.S. Das, Director, GDAD, briefed participants on Anti-dumping investigations with key provisions and specific references to Anti-dumping investigations. Mr G. Sudhakar, Chairman, and Mr Jaswanth Soundarapandian, Regional Director, participated in the Workshop.

5.13. Meeting on Development of an Export Strategy for the State of West Bengal – Kolkata – December 29, 2014

Mr Sumanta Chaudhuri, IAS, Joint Secretary, Ministry of Commerce and Industry, Govt of India chaired the meeting. The prime objective of the meeting was to develop an export strategy for the State of West Bengal. Mr Nilotpal Biswas, Regional Director represented the Council at the above meeting.

5.14. Consultations with Line Ministries/Departments/Stakeholders with reference to Rules of Origin (RoOs) in India's ongoing Regional Comprehensive Economic Partnership (RCEP) Negotiations – Udyog Bhawan, New Delhi – January 6, 2015

India is participating in the Regional Comprehensive Economic Partnership (RCEP) – a comprehensive Free Trade Agreement (FTA) between the 10 Member States of ASEAN and its 6 FTA partners, viz., Australia, China, Japan, Republic of Korea and New Zealand.

Since the primary objective of RCEP is regional integration, Rules of Origin (RoO) are expected to play an important role in determining the trade flows between the RCEP participants and in creating value chains within the region. In this context, the Department of Commerce had been seeking inputs from various line ministries/departments and concerned EPCs, to develop an appropriate approach in framing Rules of Origin (RoO) across all HS lines, with the objective to further India's export interests in the RCEP region, while providing adequate protection to our sensitive sectors.

As of now, 4 rounds of negotiations have been held by the RCEP Sub Working Group on Rules of Origin (SWGRoO), last being held in Noida in December 2014. In these discussions, it was broadly deliberated that each country would be preparing Product Specific Rules (PSRs) for each HS line at 6 digit classification. It was also observed from the deliberations so far that participating countries are not having any serious objection to have a PSR of CTH (Change in Tariff Heading) or RVC (Regional Value Cumulation) as co – equal and alternative criteria for Rules of Origin. Further, new concept of "Full Cumulation" was also being actively deliberated during discussions.

For further internal consultations and deliberations, the Department of Commerce scheduled a meeting with the concerned line ministries/departments/EPCs for HS Chapters 25 – 39 under the Chairmanship of Joint Secretary, Shri Sumanta Chaudhuri, IAS.

The meeting was held for seeking specific inputs as below:

1. Inputs / views on full cumulation in the context of RCEP
2. PSR for lines (HS Codes) relevant to the concerned EPC's along with detailed reasons for the same.
3. Any other inputs relevant to RCEP negotiations.

Mr. Sanjiv R. Dewan represented Plexconcil at the above meeting.

5.15. Conference - Progressive Maharashtra 2015, February 12, 2015 at Mumbai

FICCI - Maharashtra State Council had organized 4th edition of Annual conference "Progressive Maharashtra 2015 - Make in Maharashtra - Challenges & Opportunities". Hon'ble Chief Minister of

Maharashtra, Shri. Devendra Fadnavis has inaugurated the conference and also interacted with industry leaders in an exclusive CEO's Forum during the conference. Mrs Bharti Parave –Senior Executive represented Plexconcil at the above conference.

5.16. Meeting with Chief Commissioner of Customs, 23rd February 2015 at JNPT

There was a meeting with Mr. B. B. Prasad - Chief Commissioner of Customs organized by Dr. Kavita Gupta - Additional Director General of Foreign Trade, Mumbai at Jawahar Nehru Customs House (JNCH), Nhava Sheva. All the EPC's, Trade Promotion bodies and CHA's were invited with their issues. Councils have represented the members issues before Chief Commissioners of Customs. Mrs Bharti Parave – Senior Executive represented Plexconcil at the above meeting.

5.17. Other Trade Facilitation / Grievance Committee Meetings and individual grievances / representations from members

Other Trade facilitation and grievance redressal and related meetings convened by various Government Ministries/Departments and Agencies were attended by Council officers. Individual grievances and representations from members were also taken up individually with the Office of the Joint DGFTs, Customs Department and Central Excise Department appropriately.

Schedule '16'

1 SIGNIFICANT ACCOUNTING POLICIES

a) ACCOUNTING CONCEPT:

The financial statements are prepared on the basis of historical cost convention, in accordance with generally applicable accounting principles on going concern assumption and Council follows the accrual basis of Accounting, unless otherwise stated.

Entrance Fees receipts are credited to Corpus and Capital Fund.

b) FIXED ASSETS:

Fixed Assets are stated at cost of acquisition less accumulated depreciation.

c) DEPRECIATION:

Depreciation on Fixed Assets is provided on written Down Value based on the useful life of an asset in the manner prescribed in Schedule II to the Companies Act, 2013.

In respect of additions to fixed assets during the year, depreciation is considered on pro-rata basis. Assets costing Rs.5, 000 or less each are fully provided in the year of addition.

d) REVENUE RECOGNITION:

- I. The cost of Publications of the Council is charged to the Income and Expenditure Account in the year of incurrence of such expenses. However, the Income in respect of the same is taken into account as and when their sales are affected. The movement of Publications is controlled under the overall supervision of the Executive Director.
- II. Individual items of Prepaid expenses over Rs.5,000 only are accounted for.

e) GOVERNMENT GRANT:

- I. Grants received from Government in respect of coded activities is credited to Income and Expenditure Account on the bases of fair estimate for the same as provided by the management, on the bases of the applicable criteria prescribed by the Government for the same.
- II. Grants received for acquiring the specific fixed assets, are reduced from the cost of such assets and or at a nominal value as the case may be.
- III. Grant under MDA initiative for the benefit of Individual member exporters for the export promotion is disbursed on the bases of guidelines prescribed on this behalf and to be distributed as such to the claimant exporters. Disbursal that remains unpaid to individual exporters till the date of financial statement is reflected as current liability. However, any surplus not applied for the purpose is to be refunded to the Government of India.
- IV. Grant received by the Council for the specific studies/Project/Events approved by the Government, till the time such activities or objectives are achieved carried forward as liability. The amount spent on the projects as per the guidelines includes appropriate allocation of the administrative cost incurred by the council on the project if so mandated under guidelines prescribed for the purpose. However, any surplus not applied for the purpose is to be refunded to the Government of India.

f) RETIREMENT BENEFITS:

- I. Council's Contribution to Employee's Provident Fund maintained under the Employee's Provident Fund Scheme run by the Government is charged to Income and Expenditure Account.
- II. The Employees gratuity Liability is funded with the Life Insurance Corporation of India under Group Gratuity scheme.
- III. Leave Encashment Benefits as applicable to permanent employees are provided for on accrual basis as at the year-end as per the Council's rules. However, the said liability is not backed by specific investment for the purpose.

g) **TRANSACTIONS IN FOREIGN CURRENCY:**

Transactions in Foreign Currency are recorded at the rates of exchange in force at the time of occurrence of the transactions. The difference arising out of foreign currency fluctuations is accounted as a part of revenue or expenditure as the case may be as has occurred during the course of the year.

Current Assets and Current Liabilities in Foreign Currency at the year-end are stated at the rate of exchange in force as on that date and the resultant Gain/(Loss) is recognized in the Income and Expenditure Account.

h) **PROVISION FOR TAXATION**

The company is licensed to pursue charitable objects and is registered under section 25 of Company's Act, 1956 and registered under section 12A of Income Tax Act, 1961 and as such income is not taxable in view of exemption under section 11 and 12 of Income Tax Act, 1961.

2. NOTES ON ACCOUNTS:

- 2.1 Contingent Liability not provided for:
- The arrears calculated on the basis of 6th pay commission recommendations to the ex-employee or employee whose service are terminated amounting to Rs.3,73,920/-.
 - The council is registered under Service Tax law w.e.f.1.4.2010 and discharging its obligations, however the issues raised by the service tax authorities as to applicability of Service Tax Liabilities for prior year starting from 1.6.2007 till the date of registration i.e.1.4.2010. The matter is being represented before appropriate authorities and exact liability, if any, is not ascertainable at this stage.
 - Income Tax matter contested in appeal before appropriate authority Rs.13,02,840/-out of which 50% amount of Rs.651,420/- paid during the year.
- 2.2 The expenses in respect of Code-activities are subject to sanction/confirmation of the Government of India and Grant-in-aid received from the Ministry of Commerce is subject to adjustments in the light of Government Audit, non/partial fulfillment of certain conditions for eligibility of such Grant-in-aid, clarifications by the Council and final decision of the Ministry.
- 2.3 There are no dues which are overdue to Small Scale and / or Ancillary Industrial Suppliers as at the year-end.
- 2.4 As per the consistent accounting policy followed, the Council has not accounted for the Stock of Publications / CD's as the said publications / CD's are generally meant for distribution at the Exhibitions/ Seminars, and those remaining unsold for a period of two years or more have negligible realizable value.
- 2.5 Fixed Assets being equipment, which was acquired from the financial support from the Government, retired from active use pending formal approval from the Govt. of India for write-off is shown as provision for diminution in the value of fixed assets amounting to Rs 106,240/-.
- 2.6 Pursuant to the approval by the Finance Division of the Department of Commerce, Government of India for grant of Marketing Development Assistance (MDA) to individual exporters under certain eligible schemes, the Council has received from the Ministry of Commerce Rs. 100,00,000/- (Previous Year Rs. 97,00,000/-) and Rs.18,31,097/- (Previous Year Rs 55,44,148/-) is reimbursed to the members during the year. The pending disbursement to the eligible members as on 31st March, 2015 amounting to Rs. 200,83,616/- (Previous Year Rs. 42,39,565/-) is being disclosed as 'Amount due to Members' under the head Current Liabilities in Schedule 2.
- 2.7 The participation in eligible events under the Market Access Initiatives (MAI) of Government of India is approved on case to case bases. According an amount of Rs.183,20,000/- (P.Y.Rs.123,75,016/-) sanctioned and received from the Government and Utilised on the bases of the guidelines in this respect and total amount utilised is Rs.290,67,867/- (P.Y.Rs.61,16,180/-).
- 2.8 The earnings in Foreign Currency for Activities of the Council Rs 57,09,630/-(PY Rs.20,62,398/-)
- 2.9 The depreciation Charged during the year amounting to Rs.5,83,929/- is based on the new Schedule II prescribed under Companies Act 2013. Due to this change the charge to accumulated Balance in Expenditure A/c of Rs.1,93,137/- is in respect of asset which has Completed the useful life as on 01.04.2014.
