1. REVIEW OF EXPORT PERFORMANCE

The export analysis shown in Table 1 indicates that growth in 2019 - 20 was negative at 9.15% implying exports of 10.01 billion US Dollars. Plastic raw materials - the largest category - constituted 34.52% of total plastics export and recorded a negative growth of 23.71% in 2019 - 20. Export of value - added items registered a positive growth of 0.88% on account of increased sales of woven sacks / FIBC, leather cloth, medical disposables, house ware, and other moulded and extruded items among others. Value-added items formed 62.84% of total plastics export in 2019 - 20.

Plastics export in 2019 - 20, as indicated in Table 2(a) and 2(b), was a mixed bag with positive growth coming in from United States, Canada, Netherlands, Saudi Arabia and Afghanistan among others, and a decline in exports to China, UAE, UK, Germany and Italy etc. Region - wise, Europe was the most important region, followed by NAFTA and WANA.

2. PARTICIPATION AT INTERNATIONAL TRADE FAIRS / EXHIBITIONS

3. REVERSE BUYER-SELLER MEET (RBSM)

3.1. 5th CAPINDIA 2019, Mumbai - December 2 - 4, 2019

The 5th Edition of CAPINDIA 2019 exhibition and concurrent Reverse Buyer- Seller Meet (RBSM) was held under the aegis of the Department of Commerce, Government of India from 2nd – 4th December, 2019 at the Bombay Exhibition Centre, Mumbai. CAPINDIA 2019 is a Joint initiative of four EPCs- PLEXCONCIL, CHEMEXCIL, CAPEXCIL and SHEFEXIL under the EP (CAP) Division of Department of Commerce, Ministry of Commerce and Industry, Government of India, for the promotion and growth of export from Plastics, Chemicals and allied sectors in India. Plexconcil was the lead council for this edition of CAPINDIA, and Chemexcil ably supported & assisted the lead council to ensure the successful organization of the exhibition- cum Hosted Buyer Seller Meet. The Exhibition was supported by various trade bodies, Industry association such as IFIBC, AIFTMA, FRP Institute, GSPMA, IPF, SPMA, TIDCO, OPPI, PLASTINDIA Foundation, AIPMA and more. Over 458 exhibitors, 7,000 visitors, and 352 hosted Buyers from over 53 Countries were part of the event The RBSM created immense opportunities for India exporters expansion to global market.

The Chennai office participated at the COMPACK World of Products (Plastics+Rubber) and Packaging Exhibition 2019 organized by M/s. Smart Expos, at the Chennai Trade Centre in Chennai, from July 11-13, 2019.

The Show is a sourcing platform for plastic and packaging products and was organized to showcase the advancements and growth of the plastics and rubber sector in India. Participation at this event also provided a platform to encourage industry entrepreneurs to enrol into Council membership. Around 3 or 4 new entrepreneurs and traders evinced interest in Council membership, and to start exporting with the Council's support and guidance.

4.2. 10th IPLEX 2019 (International Plastics Exposition) Exhibition, Bangalore – August 23 - 25, 2019

The Council participated at the 10th edition of International Plastics Exposition (IPLEX) 2019 which was held at the Bangalore International Exhibition Centre (BIEC), Bangalore from August 23-25, 2019.

The IPLEX 2019 Exhibition was inaugurated by the Chief Guest Shri. D.V. Sadananda Gowda, Hon'ble Union Minister for Chemicals & Petrochemicals, Government of India. The inaugural session began by watering a plant, instead of lighting the lamp, to emphasize the plastic industry's concern for the environment. Shri. Plexconcil addressed the industry on potential initiatives to convert the district as an "Export Hub".

5.15. Export Awareness Seminar/Easy Access to Working Capital Needs, Kolkata – February 28, 2020

PLEXCONCIL in association with CHEMEXCIL, O/o Addl. DGFT, Kolkata, IPF, Drip/C organized the seminar. Mr. D. Satish, Joint Commissioner(Port), Kolkata Customs, Dr. Rahul Singh, Dy DGFT, Mr. N. Choudhury, Asst. Director, MS.ME Di, Kolkata, Mr. Prasan Lohia, Regional Chairman, Mr. Amit Pal, COA Member, and Mr. S. G Baradi, ED, CHEMEXCIL spoke at the seminar. A presentation by Drip/C on "Easy Access to Working Capital Needs" was made and participants interacted with the Government officials/speakers. The seminar ended with vote of thanks to the chair.

5.16. Export Awareness Seminar, Panipat, Haryana – February 29, 2020

The Council organised an Export Awareness Seminar in Panipat on Saturday, 29th February, 2020, in association with local plastic associations of Panipat to create awareness about the export potential for plastic items, and promote export of plastics from Haryana. The seminar was Supported by the Ministry of Commerce & Industry and ECGC Ltd. And was supported by the Directorate General of Foreign Trade (DGFT). Present at the occasion were Mr. Vikram Bhadauria, Regional Chairman, Plexconcil, Mr. Jaipal, Deputy DGFT, Panipat and senior officials from ECGC Ltd., and District Industries Centre, Panipat.

The objective of the seminar was to highlight & explain the export potential of the plastic industry, with particular emphasis on the export potential of plastic items produced in Haryana. The Niryat Bandhu Scheme, and other various schemes & policies implemented by Department of Commerce, Ministry of Commerce & Industry, ECGC Ltd. and the Haryana State Government Scheme, to promote exports were also highlighted at the seminar.

The Council highlighted the major markets for export of plastic items produced in and around Panipat, the financial assistance available for exports and basic guidance on how to export and encourage the plastic processors in and around Panipat to enter into exports. The Council highlighted the various international trade fairs it organized as well as the CAPINDIA 2019 Buyer-Seller Meet in Mumbai, where the Council invited foreign buyers from over 35 countries.

Mr. Vikram Bhadauria, Regional Chairman, PLEXCONCIL, in his welcome address emphasized the importance of exports in a challenging economic environment, reduction in import duties under the various Free Trade Agreements being signed by India, export opportunities for plastic goods etc. He also urged Plastic Processors to tap the huge opportunity, stating that Plexconcil would hand hold newcomers and provide all necessary guidance.

Deputy DGFT, Panipat, Mr. Jaipal highlighted the Niryat Bandhu Scheme which encourages and mentors entrepreneurs wanting to enter exports. He also highlighted the Advance Authorisation Scheme, and Export Promotion Capital Goods Scheme (EPCG) of the Government under which raw materials and capital goods required for export production could be imported on duty free basis.

Representative from District Industries Centre, Panipat, highlighted the Export Promotion Scheme of the Haryana State Government.

Officials from ECGC Ltd., Panipat, highlighted the services offered by ECGC Ltd. to protect the exporter from default in payment by the foreign buyer.

5.17. Export Awareness Seminar, Mumbai - March 5, 2020

An Export awareness seminar was organised by Plexconcil jointly with Ministry of MSME, MSME DI, Mumbai on March 5th, 2020 at Hotel Courtyard Marriott, Mumbai. The session was divided in two parts including a Seminar on "Intellectual Property Rights (IPR)" by Ministry of MSME and Export Awareness Seminar on "Boosting Trade Through Exports". Dr. Shri A R Gokhe - Director MSME DI welcomed the participants. Importance of Patents, Industrial Design, Copyright Cell for IPR Promotion and Management (CIPAM), Ministry of Commerce & Industry; and the Importance of Trademark & Government Benefits for IPR Ministry of MSME, MSME DI Mumbai, GoI were discussed.

Seminar on "Boosting trade through exports" started with welcome note by Shri. Nimesh Sayani -Regional Chairman - WR, Plexconcil followed by an address by Shri Jagat Killawala - President, The All India Plastics Manufacturers Association (AIPMA), an address by Shri Deepak Lawale – Secretary General-Organisation of Plastics Processors of India (OPPI) and an address by Dr. M. A Shenoy – Vice President Indian Plastics Institute (IPI). The role of DGFT in Exports & Niryat Bandhu Programme by Shri Devender Singh, ITS – Dy. DGFT Office of Addl. Directorate General of Foreign Trade (DGFT), Mumbai was highlighted. The Importance of Exports Inspection Agency by Shri C B Kotak - Dy. Director & Shri Kuldeep Singh – Dy. Director (Tech) Exports Inspection Agency, Mumbai as well as the importance of Customs. in Export / Import - Jawaharlal Nehru Customs. House, Nhava Sheva was highlighted as well. The Role & Importance of ECGC in Exports by Shri. Pawan Kumar Burman – Sr. Manager Export Credit Guarantee Corporation of India (ECGC Ltd.) and Understanding Exporter challenges & problems in logistics by Cogoport solutions - Ms. Rubi Solanki, Growth Strategist, COGOPORT were presented. Benefits of Exports & Plexconcil Membership was presented by Mr. Krunal Goda, Plexconcil. This was followed by an interactive session with the participants.

5.18. Export Awareness Meet – 2020, "Current Scenario & Way Forward for Indian Plastics Industry", Chennai – March 13, 2020

The Plastics Export Promotion Council – Southern Region with the Zonal Joint Director of Foreign Trade – Chennai jointly organized the Export Awareness Meet – 2020 titled "Current Scenario & Way Forward for Indian Plastics Industry" on 13th March 2020 at Chennai. The event was organised in association with

TAPMA (Tamil Nadu Plastics Manufacturers Association. Thiru. Dr. M.K. Shanmuga Sundaram, IAS, Development Commissioner, MEPZ (Madras Export Processing Zone) inaugurated the event. Ms. Sudha Koka, Commissioner of Customs – Exports explained about the "ease of exports" and the schemes for exporters operational at the Chennai Customs. She said that she was glad to see greater industry participation at the "export awareness meet" which demonstrated the potential for Plastics exports from Tamil Nadu. Thiru. D.K. Sekar, I.A & A.S, Zonal Additional DGFT, Chennai said that his office was open for any interaction with the exporter and that most of the grievances had been resolved and hence no "open house" meetings were being conducted presently. He also congratulated Plexconcil and assured participation at future such meets in other parts of Tamil Nadu. Mr. Y.V Raman, Regional Chairman, Plexconcil, South talked about the services being provided by the Council to its members. Mr. S. Rakkappan, President, Tamil Nadu Plastics Manufacturers Association talked about the services of his association and about the latest 100 acres cluster park being promoted and operated by TAPMA. Mr. Suresh Babuji, Director MS.ME DI talked about the various schemes under the MEME for exporters and urged the members to avail the same to expand their export business. Mr. Ruban Hobday, Regional Director – South, Plexconcil proposed the "vote of thanks".

6. OTHER MEETINGS

6.1. Meeting under the Chairmanship of Hon'ble Commerce & Industry Minister on Strategy to balance India China Trade, New Delhi – April 4, 2019

The Hon'ble Commerce & Industries Minister who addressed the meeting briefly, emphasized on increasing our exports to China, to reduce our trade deficit with the country. He emphasized on the need to have a business strategy for China, and to aggressively participate in the trade fair for imports organized in China.

The Commerce Secretary, DGFT, and Secretary DIPP, who were also present at the meeting, emphasized the need to strengthen our technical regulations, as a lot of Chinese companies exporting to India, were not being subjected to any technical regulations.

The Council informed all present that over 90% of plastic exports to China comprised plastic raw materials and Human Hair. While there had been a major increase in the export of plastic raw materials to China, Human Hair export to China suffered primarily on account of under invoicing, and the illegal trade taking place from North East India through Myanmar to China. The Representative from the Human Hair sector, who was also present at the meeting, further elaborated on the two issues. The Commerce Secretary assured the Council of referring the matter to the Department of Revenue.

Mr. Sanjiv R. Dewan, Regional Director, and Mr. Sunil Eamani of M/s Indus Hair Extensions, representing the Human Hair sector were present at the meeting.

6.2. Interaction of the Commercial Representatives with the Heads of various Export Promotion Councils, New Delhi – April 8, 2019

Foreign Service Institute (FSI) organized an interaction of EPCs with the Commercial Representatives (CRs) from select countries in Africa, North America and Latin America. The interaction was held to familiarize the CRs with the expectations of the EPCs and note the concerns of the CRs.

The EPCs requested the CRs to promote their events on the embassy's website and suggest suitable buyers for the various RBSMs held by the EPCs in the country. They also requested them to inform the EPCs of any Non-tariff barriers in their respective countries, which may impact exports from India. Plexconcil requested the CRs to suggest suitable buyers for the proposed CAPINDIA in March, 2020 and informed them of the Council's participation at some exhibitions in Africa and Latin America.

CRs from Latin American countries expressed concern that quite often brochures prepared by EPCs are not translated in the local language, i.e. Spanish/Portuguese, which is extremely important for the Latin American region. They also requested that EPCs email their entire calendar of events for the current financial year to them. They also offered to upload any promotional videos the Council may have prepared, on the embassy's website.

Mr. Sanjiv R. Dewan, Regional Director represented Council at the interactive meeting.

6.3. Preparatory meeting on India-Nigeria Joint Trade Committee (JTC) Meeting, New Delhi – April 10, 2019

A meeting chaired by the Jt. Director, Africa Division was held to discuss issues that could be taken up with the Nigerian authorities at JTC meeting scheduled from April 29-30, 2019, at New Delhi.

Plexconcil took up the issue of the mandatory inspection certificate (SONCAP certificate) insisted upon by the local Nigerian inspection agency. It was suggested that inspection certificate issued by our agencies should be made acceptable. It was also suggested that EXIM bank could extend Buyer's credit to Nigeria, in order to enhance our exports to Nigeria. High tariffs imposed by Nigeria on import of some of the plastic items, were also highlighted.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.4. Inter-Ministerial Meeting in connection with the 2nd Meeting of Joint Administration Committee (JAC) under expanded India-Chile PTA, New Delhi – April 12, 2019

A meeting chaired by Mr. Shyamal Misra, IAS, Joint Secretary was held to review the expanded India-Chile PTA, and to look at sectors where additional tariff concessions could be sought from Chile under further expansion of the PTA.

Plexconcil informed those present that additional tariff concessions should be sought from Chile, particularly in products such as Fishing nets, Ball Point pens, Floor coverings, FIBCs, Ropes/Twines and moulded luggage, where there was a good potential to enhancing our exports, but were challenged by a tariff disadvantage compared to competitors including China and Korea that have an FTA with Chile and hence enjoy ZERO tariff for these items.

The JS stated that a large number of exporters did not avail the benefits of the PTA with Chile, and asked EPCs to enquire from their members whether they were aware of the tariff concessions that already existed under the PTA, and if their importers were availing the benefits of the same.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.5. Session on 'Business, Trade and Investments Opportunities in Egypt' organized by CII, Chennai – April 25, 2019

The Confederation of Indian Industry (CII) organized a Session on 'Business, Trade and Investments Opportunities in Egypt' and an Interaction with Dr. Heba Salahedin Elmarassi, Her Excellency, Ambassador of Egypt to India on 25th April 2019 at Hotel Taj Coromandel, Chennai. The session outlined India Inc's strong and dynamic presence in Egypt with a number of Indian companies becoming an integral part of the Egyptian economy.

While sectors such as Infrastructure Development, Agriculture & Food Processing, Information Technology, Healthcare & Pharmaceuticals, Automobiles & Auto-Components have huge potential,

others such as Textiles & Readymade Garments, Oil & Gas, Logistics & Transportation, Mining, Renewable Energy, Retail and Construction have been identified as those with growth trajectory.

The imports from Egypt were worth US\$ 1.29 billion during FY 2017-18 while Indian exports to Egypt during the same period recorded US\$ 2.39 billion. In terms of both imports and exports, India is Egypt's 10th largest partner with bilateral trade increasing more than five times in the last ten years.

The Council was represented by Mr. R. Dayanidhi, Assistant Director at the above event.

6.6. Human Hair Association-cum-Human Hair & Hair Products Panel Meeting, Chennai – April 27, 2019

Mr. Benjamin Cherian, Panel Chairman (Human Hair & Hair Products Panel, Plexconcil) and President, Human Hair and Hair Products manufacturers and Exporters Association of India (HHHPMEAI), convened a meeting with members of the Human Hair Association on Saturday, 27th April, 2019, at the Presidency Club, Chennai. He briefed members on the steps taken by the Association with support and assistance from Plexconcil in the last 4 years to represent and lobby for the ban on export of goli/chutti hair, and for preventing the under-invoicing and smuggling of human hair to Myanmar and China by unscrupulous traders, including Myanmar and Chinese nationals (which has hit genuine exporters and also resulted in major loss of jobs), through numerous representations made to the Commerce Secretary and the Zonal Additional DGFT (through Plexconcil), and various personal visits to Ministry meetings, and the recommendations obtained as a result of such an effort.

Follow up measures were discussed, and a core sub-committee was formed to meet the Government Departments including DGFT, CBEC, DRI and the anti-smuggling agencies, for implementation of the recommendations, to enable growth of Human Hair & Hair Products exports.

Mr. Cherian called for the formation of the Human Hair & Hair Products Panel and the following members were unanimously nominated to the Human Hair & Hair Products Panel – Mr. Benjamin Cherian, Raj Hair International Pvt. Ltd., Chennai, Mr. M.M. Gupta, Gupta Enterprises, Chennai, Mr. K.K. Gupta, Srinivasa Hair Industries, Eluru, Mr. Srinivas Kanala, Sheelu Exports, Eluru, Mr. Satish Gandhi, Allure Hair Products Pvt. Ltd., Chennai, Mr. M. Somasundaram, Temple Hair Impex, Chennai, and Mr. Sunil Eamani, Indus Hair Extensions, Hyderabad. The Panel decided to meet at least once every quarter, or more, if the occasion so demanded.

The Panel would also co-ordinate with the Association's sub-committee to monitor the implementation of the recommendations by various Government Departments such as DGFT, CBEC, DR.I and the antismuggling agencies to ensure curbing of under-invoicing and smuggling of hair to Myanmar and China by unscrupulous traders.

Suggestions/recommendations would be made to the Plexconcil on export marketing support required by identifying and recommending appropriate International Trade Fairs for the sector to participate for growth of Human Hair and Hair Product exports.

Mr. Jaswanth Soundarapandian, Regional Director, and Mr. R. Dayanidhi, Assistant Director attended the meeting.

6.7. Meeting with the Delegation of Chile under expanded India-Chile PTA, New Delhi – April 29, 2019

A meeting chaired by Mr. Shyamal Misra, IAS, Joint Secretary was held wherein the Council made a presentation to the delegation from Chile, highlighting the strengths of the Indian plastics industry. The presentation also focused on the specific product lines where India had superior product quality, and could effectively meet the needs of the Chilean market, if ZERO tariff was extended on these product lines making Indian exports comparable to China and Korea that enjoyed ZERO tariff as a result of their FTAs with Chile. Other EPCs that made presentations included Pharmexcil, EEPC, and Chemexcil.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.8. Meeting to facilitate Participating Government Agencies (PGAs) to onboard the e – Sanchit platform, New Delhi, April 29, 2019

The meeting was chaired by Mr. Rajneesh, IAS, Joint Secretary (JS) and he requested all EPCs to take the following actions urgently:

- Any issues being faced by EPCs regarding integration with the e-Sanchit platform, to be immediately highlighted to the E&MDA Division, so that they may take up the same with CBIC. Email to be sent to E&MDA Division, latest by 15th May, 2019, confirming integration with e-Sanchit and registration on their Portal.
- Process of issuing Certificate of Origin (COO) to also be made online latest by 31st May, 2019.
- Process of payments made by EPC members towards membership fee, Certificate of Origin etc. to be online only, whether through NEFT/RTGS or credit card etc.

The Council informed the JS that it had already started issuing RCMC online, and it would highlight faced with CBIC issues, if any. The JS sought an email from all EPCs, confirming compliance on the abovementioned points by 15th May, 2019. Issues being faced with CBIC were to be highlighted immediately to E&MDA Division.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.9. Release of Study Report conducted by Research & Information Centre for Developing countries (RIS) on "India's Economic Engagement with LAC- Strategy for Trade and Investment", New Delhi – May 6, 2019

The study report on "India's Economic Engagement with LAC - Strategy for Trade and Investment", was released by the Commerce Secretary on 6th May, 2019. The Commerce Secretary urged all EPCs/trade bodies to share the report with their members, and utilize the report to fine tune the strategy to boost exports to the LAC region. Joint Secretary (LAC), Mr. Shyamal Misra, urged all EPCs to share the information regarding Non-Tariff Barriers (NTBs) in the LAC region with members and obtain their feedback and solutions for the same.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.10. Meeting with the MSME Trade and Investment Promotion Bureau (M-TIPB), Chennai – May 9, 2019

The Tamil Nadu Small Industries Development Corporation Ltd. (TANSIDCO), Government of Tamil Nadu, invited the Council for a preliminary discussion on the action plan to be carried out by the newly formed MSME Trade and investment Promotion Bureau (M-TIPB) under the MSME Department, Government of Tamil Nadu, to promote Tamil Nadu's MSME Industries at leading International Trade Fairs as well as prominent Trade Fairs organized in India in 2019-20.

The meeting was chaired by Mr. T.P. Rajesh, IAS, Managing Director, MSME Trade and Investment Promotion Bureau (M-TIPB), Government of Tamil Nadu. Apart from officials from TANSIDCO and the Directorate of Industries & Commerce, officials from FIEO, EEPC, TANSTIA, AIEMA and PLEXCONCIL participated at the meeting, and had a fruitful brain-storming discussion to promote the MSME sector from Tamil Nadu, which has emerged as the highly vibrant and dynamic sector in the Indian economy.

Mr. Jaswanth Soundarapandian, Regional Director, and Mr. R. Dayanidhi, Assistant Director, Plexconcil, participated in the meeting, highlighting the participation and facilitation of 10 MSME manufacturers by TANSIDCO in the Tamil Nadu State Pavilion at the CAPINDIA 2019 in Mumbai, and urged their participation in the next year's edition with a larger contingent and space.

Mr. Jaswanth also submitted the Council's calendar of International Events for the year 2019-20 and urged TANSIDCO to facilitate MSME manufacturers from the plastics sector to participate in the Council's overseas events under their "Export Promotion and Marketing Support Scheme".

6.11. Plexconcil Panel Meeting (Pipes and Fittings Panel), Chennai – May 9, 2019

The first meeting of the Pipes and Fittings Panel for fiscal 2019-20 was held May 09, 2019 at the Council's Regional Office in Chennai. The Panel Chairman, Mr. P. Mohan, welcomed the Regional Chairman (Special Invitee) for attending and all Panel members and thanked them for having consented to serve in the Pipes and Fittings Panel. He said that the role of the Product Panel was to enable members discuss export-related issues and problems and also suggest export promotion initiatives to the Committee of Administration for implementation, for the growth of the Pipes and Fittings products' exports from India.

The panel had detailed discussions on ways to enhance and grow exports of the Pipes and Fittings from India. The Panel Chairman called for suggestions and recommendations for enhancing exports by moving to newer technologies, support through Export Promotion Initiatives, highlight obstacles the industry was facing in the tax/duty structure and policies. He also informed members that the suggestions/ recommendations received during the meeting would be highlighted at the next CoA meeting for necessary appropriate action.

Members and officials were present at the meeting were Mr. P. Mohan, Sakkthi Polymers, Salem (Panel Chairman), Mr. K. Balaji, Sri Sapthagiri Polymers, Erode, Mr. Uday Adhikari, Al-Aziz Plastics Pvt. Ltd., Mumbai, Mr. Sushil Rungta, Agro Pipes (P) Ltd., Chennai, and Mr. Y.V. Raman, POCL Enterprises Ltd., Chennai (Regional Chairman and Special Invitee). Mr. Jaswanth Soundarapandian, Regional Director, and Mr. R. Dayanidhi, Assistant Director, represented the Council in the meeting.

6.12. Meeting regarding the Introduction and Enforcement of Chemical regulations, New Delhi – May 17, 2019

A meeting chaired by Mr. Shyamal Misra, Joint Secretary (JS) was held to discuss the proposal of the Department of Commerce for the introduction and enforcement of Chemical Regulation in the country. The Regulation is proposed to be introduced in two steps, starting with the preparation of National inventory of chemicals.

The JS asked the representative of Chemexcil about the inventory on Chemicals prepared by them and asked him to upload the same on the Council's website.

Representatives from the Centre for Trade and Investment Law (CTIL) briefed the JS about the Dr.aft Chemical (Safety) Rules which have been prepared after studying various countries' practices on the same. JS requested all present to furnish suggestions on the draft rules by the end of the month. Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.13. Meeting with Joint Secretary (Customs), CBIC to discuss issues faced by Human Hair exporters, New Delhi – May 28, 2019

The Council met with the Joint Secretary (Customs) for exporters from the Human Hair sector to discuss issues of illegal trade and under invoicing in export of Human Hair.

The Joint Secretary (JS) was informed that the issues had already been highlighted by the Council with Department of Commerce and with DGFT. The JS was apprised of the severe challenges faced by Human Hair exporters due to the illegal trade, particularly from the North East to Myanmar and from there to China. The JS enquired about the specific border areas in the North East where the illegal trade occurred and was duly informed. Human Hair exporters also explained the complete process of under invoicing and illegal trade, with specific inputs about the way products were being transported and the border check posts where it takes place. The JS assured to investigate the issue and send an alert to Customs at the particular border check – posts.

Human Hair exporters comprising of Mr. Sunil Eamani, Mr. M.M. Gupta, Mr. Satish Gandhi, Mr. K.S. Rao along with Mr. S.R. Dewan, Regional Director, Plexconcil, attended the meeting.

6.14. Boosting exports to China & USA in view of USA–China Trade War – Meeting with stakeholders of identified tariff lines, New Delhi - June 7, 2019

The meeting was chaired by the Commerce Secretary (CS) and the Embassy of India (EOI), Beijing participated at the meeting through Video Conferencing facility.

The CS stressed that EPCs need to be proactive in urging their member exporters to exploit the opportunities arising out of the USA – China trade war. Within plastics sector, opportunities had arisen in 53 tariff lines where USA had imposed increased tariffs on China, and 44 tariff lines where China had imposed a tariff of 25% on USA. The CS urged EPCs to study the same and look into the possibility of increasing exports on these tariff lines. Stakeholders present requested our Embassy in Beijing for details of Chinese importers of the identified tariff lines who were importing from USA.

EOI, Beijing emphasized that exporters should participate in the China International Import Expo taking place in November 2019 in China. The Vice Chairman, Mr. Arvind Goenka stated that his company planned to participate in the said Expo. The Council also requested EOI, Beijing for assistance in getting more space at the ChinaPlas exhibition at which it has been a regular participant.

Mr. Arvind Goenka, Vice Chairman, Mr. Sribash Dasmohapatra, Executive Director, Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.15. Interaction with stakeholders / exporters of chemicals, plastics & allied products sectors to identify initiatives to boost exports and to reduce imports, New Delhi - June 11, 2019

During a meeting chaired by the Joint Secretary (JS), Mr. Shyamal Misra, IAS, all present were urged by the JS to exploit the opportunities to boost exports both to USA and China in view of their ongoing trade war. He also stressed the need to reduce imports, through import substitution and by curbing non - essential imports. He stressed on the need to alert the Government on any large surge in imports, particularly from any of the FTA countries, and to report imposition of any new Anti-Dumping Duties by any of the countries on exports from India.

Plexconcil Vice Chairman highlighted the suggestions made by some Associations to increase import duty on PVC Resin, which he said would harm the downstream processors of PVC products. JS advised that the issue should also be taken directly with the Ministry of Finance. Plexconcil Regional Chairman (North) explained that the negative growth in plastic raw material exports in April 2019 was due to a drop in international prices, and the prices were now showing an upward trend, which would result in positive growth in raw material exports, going forward. The Representative from Luxor Writing Instruments explained that export of Writing Instruments from India faced high tariffs in some of the potential countries, as compared to competitors, and this needed to be addressed through FTAs.

The Representative from the Human Hair sector highlighted the issue of illegal trade of Human Hair from the North – East to China, via Myanmar, and the issue of under invoicing. He was advised to pursue this case with CBIC/Customs.

Mr. Arvind Goenka, Vice Chairman, Mr. Vikram Bhadauria, Regional Chairman(North), Mr. R.V. Mathur (Luxor Writing instruments), Mr. Sunil Eamani (Indus Hair Extensions), Mr. Sribash Dasmohapatra, Executive Director and Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.16. Meeting for logistic requirement for various chemical – handling facilities available at Indian Ports, New Delhi – June 17, 2019

The meeting was chaired by Secretary (C&PC) to discuss present logistics/infrastructure available at different Indian ports, and their future plans for expansion to handle increasing business in Chemicals & Petrochemicals.

Some of the issues highlighted to help improve the logistics/infrastructure at different Indian ports were:

- Inadequate berthing availability for bulk vessels bringing or taking chemicals from ports resulting in high demurrage cost to chemical companies.
- Non availability of rail connectivity, inadequate berthing space (in terms of draft, width, number of berths) resulting in non-utilization of some ports.
- Lack of IT infrastructure for tracing container at Nhava Sheva, Kandla & Chennai ports.
- Delay in testing in Custom laboratories hampering early clearance of consignments.
- Delay in custom clearing due to repeated failure of ICEGATE system. If the ICEGATE system does not work, manual custom clearing should start immediately.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.17. Interactive Meet chaired by Shri Som Parkash, Hon'ble MOS (C&I) with stakeholders/exporters of Chemicals, Plastics, Minor Forest produce & allied products Sectors of the EPCs along with concerned line Ministries/Departments, New Delhi – June 25, 2019

The meeting was chaired by the Hon'ble MOS (C&I), Shri. Som Parkash, to discuss the issues hampering growth in exports.

Major issues highlighted by our COA members and member exporters were the permission to import virgin PVC industrial scrap, which was not forthcoming, the illegal trade and under invoicing in Human Hair which continues, and the urgent need for Technology Upgradation in the plastics sector. Other issues discussed were the HS Code mismatch in case of Master batches while exporting to Bangladesh, resulting in high import duty being imposed by Bangladesh and a request to address the GST issue on FIBC. The Minister requested the concerned officials from the line Ministries that were present, to respond to the issues highlighted, at the earliest.

Mr. Ravish Kamath, Chairman, Mr. Arvind Goenka, Vice Chairman, Mr. Vikram Bhadauria, Regional Chairman (North), Mr. P. Mohan, Member COA, Mr. Sunil Eamani Member Exporter from the Human Hair sector, Mr. Sribash Dasmohapatra, Executive Director and Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.18. Interaction with stakeholders of identified lines for boosting exports to USA, New Delhi – June 25, 2019

The meeting was chaired by the Commerce Secretary (CS) and the Embassy of India (EOI) Washington DC, participated at the meeting through Video Conferencing.

Plexconcil highlighted that 272 tariff lines had been identified where India has good export potential, based on the 25% tariff imposed by USA on China. The CS urged all present to seize this opportunity before other countries could take advantage of the situation.

The embassy in Washington DC was requested to identify the relevant product specific associations in USA, while EPCs were requested to identify the relevant exporters and organize a BSM in USA.

EPCs were also advised to inform the embassy about all the RBSMs being organized in India to enable them to send relevant buyers from USA.

Regional Chairman (North) informed that planned to lead a delegation to USA in August for an BSM to boost plastic exports to USA particularly for those items where new opportunities had risen. The Embassy expressed complete support but also cautioned that USA had very stringent standards and one must be aware of these in order to avoid trade disputes. The Embassy also advised exporters to not take on commitments that cannot be met, particularly in terms of delivery and quality.

Mr. Vikram Bhadauria, Regional Chairman (North), Mr. Sribash Dasmohapatra, Executive Director and Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.19. Meeting regarding identification of Trade Barriers and Market Access Unfairness in Africa &WANA Region, New Delhi – June 27, 2019

A meeting was chaired by the Joint Secretary (Africa) to discuss the following issues: -

- (i) To understand if there exists any market access unfairness in Africa and WANA Region and deriving alternative methods to enhance the trade.
- (ii) Identification of Trade barriers in the Africa and WANA region.

The JS informed that the meeting was being held to particularly understand Non-Tariff Barriers (NTBs) that India faces in Africa and the WANA region, and requested all stakeholders present to share information about their respective sectors. Regarding plastics sector, Plexconcil highlighted the inspection certificate (SONCAP Certificate) being insisted upon by the local authorities in Nigeria. It was informed that the cost to be borne by the exporter for such a certificate was US\$ 250/= at the minimum and that the matter be taken up with the Nigerian authority. It was suggested that Nigeria should accept the inspection certificates issued by Indian Inspection Agencies.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.20. 1st Quarterly Meeting of Export Facilitation Cell of MSME-DI, Kolkata – June 28, 2019

MSME–DI has set up an Export Facilitation Cell (EFC) under the control of Development Commissioner (MSME), New Delhi. The main functions of the EFC are to explore the untapped

potential of MSME sector to boost export from Domestic Tariff Area (DTA) and Special Economic Zones (SEZs) by promoting MSMEs and clusters in them. The EFC will facilitate existing and prospective MSMEs and clusters by providing handholding supports and mentoring. The EFC shall also work for developing mini clusters in SEZ particularly in West Bengal under MSE-CDP scheme of DC(MSME), New Delhi to establish common facility centres. National Resource Centre (NRC) established at MSME – DI, Nagpur will work as a Nodal support centre for EFC of this Institute.

- As a part of an action plan for EFC in the year 2019 20, the Institute organized this quarterly meeting with Industry Associations, State Govt., Clusters, Development Commissioner (SEZ), EPCs, DGFT and others Stake holders to develop a sustainable ecosystem for handholding assistance to MSMEs to boost up Export growth in MSME sector in the state of West Bengal and U.T. of Andaman and Nicobar Island.
- There was a presentation by the MSME-DI highlighting the export promotion scheme which includes trade fair participation, Mini Cluster in SEZ scheme, GST reimbursement scheme etc. We have been requested to promote these schemes.
- Mr. Nilotpal Biswas, Regional Director represented the Council at this meeting.

6.21. Meeting with the Commissioner Customs to discuss issues of Human Hair Exports, New Delhi – July 5, 2019

The Council met Mr. M.G. Thamizh Valavan, Commissioner Customs for exporters from the Human Hair sector to discuss issues of illegal trade and under Invoicing in export of Human Hair.

The Commissioner was apprised of export of Human Hair being badly impacted by the illegal trade taking place, particularly from the North East to Myanmar and from there to China. The Commissioner enquired about the particular border areas in the North East from where illegal trade was taking place and was duly informed. The concerned exporter at the meeting also highlighted the complete process of under invoicing and illegal trade with specific inputs on transportation methods and the particular border check posts where it occurred. The Commissioner agreed to address the issue and present the case to Directorate of Revenue Intelligence (DRI) as they are the nodal organization that works at operational levels.

Human Hair member exporter Mr. Sunil Eamani, along with Mr. Anuj Sharma, Senior Executive, Plexconcil, attended the meeting.

6.22. Export Awareness Programme during IPLEX 2019 Roadshow and Launch function, Chennai – July 13, 2019

The Tamil Nadu Plastic Manufacturers Association (TAPMA) invited the Council to be part of the IPLEX 2019 Roadshow and Launch function and make a presentation on 'Export Opportunities for Plastic Products' for the benefit of TAPMA members. The event, held at the Hotel Ambassador Pallava, Chennai, was supported by the Karnataka State Plastic Association (KSPA), Bangalore, the host state for this year's IPLEX 2019 Show, scheduled to be held from August 23-25, 2019 in Bangalore.

Mr. Virendra Bayani, President of Tamil Nadu Plastic Manufacturers Association (TAPMA) welcomed the gathering, which was followed by presentations on 'GST Amendments and Updates', made jointly by Mr. A.P. Ravi, Advocate, and Mr. Jeevan Kumar, Chartered Accountant. Mr. Y.V. Raman, Regional Chairman, Plexconcil, made a detailed Presentation on 'Export Opportunities for Plastic Products and Plexconcil Services', and emphasized the importance and rewards of venturing into export markets. Mr. Hariram Thakkar, Convener-IPLEX 2019 Exhibition, launched IPLEX 2019 and presented the key highlights of the Show. Mr. S. Rakkappan, Secretary, Tamil Nadu Plastic Manufacturers Association (TAPMA), proposed the vote of thanks. Around 180 plastic industry entrepreneurs and professionals participated in the Roadshow. Mr. Jaswanth Soundarapandian, Regional Director, Mr. R. Dayanidhi, Assistant Director and Ms. Devi, Junior Executive represented the Council at this event.

6.23. Meeting of our Council and AIPMA with Joint Secretary, Mr. Shyamal Misra, New Delhi – July 30, 2019

The meeting was attended by Mr. Deepak Ballaney and Ms. Soumya from AIPMA. Deputy Secretary, Mr. S.K. Ranjan was also present. The main agenda of AIPMA was to invite the JS for their event scheduled on 9th August, 2019, at New Delhi.

Following points were highlighted by the JS at the meeting:

- AIPMA and Plexconcil to share their reactions on the Outcome of the Budget with DOC and the various announcements that impact the plastics industry.
- AIPMA and Plexconcil to either jointly write or substantiate each other's views regarding the recent discussions held by the CIM, Mr. Piyush Goyal, on RCEP. To highlight only the most important issues impacting the plastics industry during the RCEP discussions.
- AIPMA and Plexconcil should write to the RMTR Division / RCEP team that went for the negotiations to China, regarding the outcome of the discussions that were held.
- DOC to be kept informed about Non-Tariff Barriers (NTBs) or any other unfair treatment that exporters face while exporting to any country. A database of such issues should be built and periodically updated.
- Plexconcil to respond to the issue raised by AIPMA regarding shifting of used moulds by USA from China to India, for production of plastic items. in India. DS informed that an email had been sent to Plexconcil seeking its views on the same.
- Regarding TUFS for the plastics sector raised by Mr. Ballaney, JS said that as it was not under the purview of DOC to fund the same, but they would recommend it, as and when the matter is referred to them.

The JS also informed that a meeting to discuss Export Strategy was proposed to be held in Mumbai on 7th August, 2019.

Mr. Sanjiv R. Dewan represented Council at the meeting.

6.24. Interactive Session with Hon'ble Minister, Mr. Piyush Goyal on emerging opportunities to enhance India's exports to USA and China, New Delhi – July 31, 2019

Following issues were highlighted by the Hon'ble Minister, Mr. Piyush Goyal, at the above mentioned interactive session organized by FIEO at Hotel Ashok, New Delhi:

- Government was moving towards RODTEP and phasing out MEIS. Associations /EPCs to compile data and estimate the quantum of RODTEP for their particular industry. Any State or Central levy should also be highlighted to the Government for reimbursement.
- Any unfair trade practice or dumping of products into India by any country should be highlighted to DOC. Any kind of protectionist policies being practiced by any country should also be mentioned.
- Industry should support / encourage capacity addition in raw material production within the country.
- Need to seize the opportunity emerging from the USA China trade war.
- Seize emerging opportunities to increase exports to countries with which India has a significant trade deficit.

Mr. Sanjiv R. Dewan represented the Council at the meeting.

6.25. Meeting with MOS to discuss various issues hampering growth of exports in Plastics and Chemicals sector, New Delhi – August 13, 2019

The meeting was chaired by Shri Som Nath, Minister of State during which various organizations including PLEXCONCIL voiced their views. The MOS believed that the import of nonessential goods should be reduced and exports from India, mainly of processed plastic, should increase. He invited suggestions in this regard.

IPF Kolkata raised issues such as cheap imports under India-ASEAN FTA, problems at Bangladesh & Nepal border, drawback rates to be rationalized, hike in insurance premium by 4 - 5 times, EPR rules etc.

AIPMA suggested increasing import duty on finished goods, discouraging export of raw materials and to increase tenure repayment of term loan to 10 - 15 years. They also suggested working capital limits to be increased and BIS marking on imports.

Similarly, polymer producers raised the issue of cost of manufacturing of Polymers in Middle East & USA compared to India and suggested that suitable protection be given to Polymer producers to survive and grow.

Mr. Arvind Goenka, Vice Chairman, Mr. Sachin Shah of M/s Toyop Relief, Mr. Kamal Dayal, M/s Premier Polyfilms Pvt. Ltd., and Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.26. Interactive Session with Dr. Anup Wadhawan, IAS, Commerce Secretary, Ministry of Commerce & Industry, Govt. of India, Kolkata – August 14, 2019

- > The above interactive session was organized by the EEPCINDIA in Kolkata on 14th August 2019.
- Dr. Anup Wadhawan, IAS, Commerce Secretary interacted with the members of the various Export Promotion Council's and chamber of Commerce.
- Mr. B S Bhalla, IAS, Additional Secretary, Department of Commerce and Smt. Anindita SenGupta, Additional DGFT, Kolkata was also present at the meeting.

Mr. Prasan Lohia, Regional Chairman and Mr. Nilotpal Biswas, Regional Director represented the Council at this meeting.

6.27. 1st Meeting of Chemicals & Petrochemicals Advisory Forum, New Delhi – August 27, 2019

The meeting was held under the Chairmanship of Hon'ble Minister (Chemicals & Fertilisers), Shri D.V. Sadananda Gowda. Also present were the Hon'ble Minister of State (Chemicals & Fertilisers), Shri Mansukh Mandaviya, Secretary Department of Chemicals & Petrochemicals, Shri P. Raghavendra Rao, Joint Secretary (Chemicals), Shri S.K. Biswas, and senior representatives from various Associations from the Chemicals and Petrochemicals sector.

Some of the major issues highlighted at the meeting included the need to bridge the demand & supply gap for plastic raw materials, the delays in getting environmental clearances for setting up a unit in the chemicals sector, the need to have a relook at various FTAs, which have resulted in inverted duty structures, speedy implementation of PCPIRs etc.

Plexconcil represented by Vice Chairman, Mr. Arvind Goenka and Regional Chairman, Mr. Vikram Bhadauria, highlighted issues regarding the urgent need for a Technology Upgradation Fund (TUF) for the plastic processing sector, implementation of BIS Standards for finished plastic goods, availability of plastic raw materials to exporters on deemed export basis by PSU companies such as IOCL, allowing import of post-industrial PVC surplus on actual user basis for manufacture and export of PVC Floor coverings, need

for setting up a regulatory body to address high inland haulage charges, and the issue of FTAs, particularly with ASEAN and SAARC countries which are hurting domestic industry.

Mr. Arvind Goenka, Vice Chairman, Mr. Vikram Bhadauria, Regional Chairman (North), Mr. Kamal Dayal, V.P., Premier Polyfilms. Limited & Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.28. Meeting to discuss Negotiations under the proposed Economic & Technology Cooperation Agreement (ETCA) with Sri Lanka, New Delhi – September 4, 2019

The meeting was held under the Chairmanship of Mr. B.S. Bhalla, Additional Secretary (South Asia), to seek views of stakeholders regarding the list of products placed under the negative list by Sri Lanka under the India-Sri Lanka Free Trade Agreement. Plexconcil's earlier views regarding delisting finished plastic items from Sri Lanka's negative list, had already been incorporated by the FT(SA) Division.

Plexconcil raised the issue of the high level of cess levied by Sri Lanka on PVC products and Houseware items. and change in HS Code by Sri Lanka Customs. in case of PVC Leather cloth.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.29. Meeting on Reducing the usage of single-use plastic, and rehabilitation of plastic manufacturers, New Delhi – September 9, 2019

The meeting was chaired by Mr. Anil Agarwal, Joint Secretary (JS), DPIIT and the key focus was to deliberate the phasing out of single use plastics, and plastic waste management.

The JS stated that the two main ways of managing plastic waste were through disposal in cement plants and in road building. The issue of defining single use plastics and what plastic items are covered under it was also raised at the meeting.

Mr. O.P. Sharma, Consultant, Department of Chemicals & Petrochemicals (DCPC) stated that DCPC had constituted a committee to prepare a report on single use plastics. The report would define the items that would be covered under the ambit of single use plastics.

Representative of AIPMA highlighted the need for effective plastic waste management, and the need to rehabilitate the large number of plastic units engaged in the manufacture of single use plastic that would shut down.

Plexconcil member, Mr. Abhishek Goyal of M/s. Essel Kitchenware Ltd., emphasized that plastic products that are 100% recyclable should not be included in the list of single use plastics that are to be phased out/banned. He stated that his company manufactures disposable bowls, plates and trays made from Polystyrene which is 100% recyclable.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.30. Meeting with Industry Associations on Regulatory Instruments for Formulation & Implementation of an Effective Trade Policy and Development Strategy, New Delhi – September 11, 2019

The meeting was chaired by the Hon'ble Minister for Commerce & Industry (CIM), Shri Piyush Goyal. In his welcome address, he emphasised the need to look at our comparative advantages and utilise the same with the ultimate objective to create a competitive economy. He stated that protectionist policies cannot be the long-term objective as it would lead to inefficiencies, even if they are aimed at tackling unfair trade practices adapted by exporters of other countries.

The Additional Secretary & Director General (AS&DG), Directorate General of Trade Remedies (DGTR), gave an exhaustive presentation on Trade Defence Mechanisms, and highlighted the fact that while Tariffs have come down, Non - Tariff Barriers (NTBs), have assumed importance. He emphasised that NTBs have now become key barriers to market access in various countries. SPS & TBT measures accounted for majority of the NTBs adopted by most countries.

AS & DG also highlighted the help desk at the DGTR to help MSMEs on Trade Remedial Measures.

The Hon'ble CIM stated that we need to gradually move towards implementing/having standards for finished goods so that the consumers get world class quality goods. He also emphasised the need for Indian industries to become more competitive and compete internationally. He said that the India – ASEAN FTA was under review to address concerns of Indian industry.

From the plastics sector, major issues that were raised included having a Technology Upgradation Fund Scheme (TUFS) for the plastic processing industry, raising import duty on finished plastic products, subsidizing the cost of power and a review of various Free Trade Agreements.

Mr. Arvind Goenka, Vice Chairman, Mr. Vikram Bhadauria, Regional Chairman (North), Mr. Sribash Dasmohapatra, Executive Director & Mr. Sanjiv R. Dewan Regional Director represented Plexconcil at the meeting.

6.31. Programme on IGST Refunds Outreach Dr.ive and Sensitization of MSMEs for claiming IGST Refund, Chennai - September 12, 2019

The Council participated in a Special Outreach Programme organized by the Chennai Customs. Commissionerate at the Custom House, Chennai, on September 12, 2019. The meeting was part of the initiative of the Customs. Department to review issues of MSMEs in Tamil Nadu that includes fast tracking sanctioning of DBK, IGST refund, ITC refund, exports and Imports issues etc.

The meeting was called by Smt. Sudha Koka, Commissioner of Customs, Chennai IV. Other Senior Customs Department Officials too were present to obtain inputs and ideas for fast tracking of MSME transactions related to Customs., GST and other allied agencies. The Chief Commissioner was apprised of the slowdown in the various verticals of MSME sector, particularly in the automotive sector and other various labourintensive sectors which were facing de-growth and in need of immediate stimulus to revive growth in such sectors.

The Interactive meeting was fruitful and decisions were made to resolve the issues through the recently launched "MSME Cell" at the Custom House with representatives from Customs, CII and FIEO to monitor the functioning of the cell for the benefit of the MSME sector.

The meeting had senior representatives from CII, FIEO, ACMA, EPCs, other Trade Associations and Exporters & Importers. Mr. Jaswanth Soundarapandian, Regional Director and Mr. R. Dayanidhi, Assistant Director, represented the Council in the meeting.

6.32. CAPINDIA 2019 Promotions at TAPMA AGM, Chennai – September 22, 2019

The Tamil Nadu Plastic Manufacturers Association (TAPMA) Management Committee invited the Council to be part of their 34th Annual General Meeting on September 22, 2019, held at the Ambassador Pallava Hotel, Chennai.

During the event, in addition to promoting CAPINDIA 2019, the Council officials also highlighted Council Membership benefits to TAPMA members. The CAPINDIA 2019 flyers and Council's Membership benefits pamphlets were given to all the delegates who attended TAPMA's AGM.

The event was attended by Mr. R. Dayanidhi, Assistant Director, and Mr. S. S. Devi, Junior Executive. The Council team interacted with and met potential companies for their participation at CAPINDIA 2019, as well as for membership mobilization.

6.33. Sensitization workshop on Foreign Trade Data, Kolkata – September 26, 2019

O/o DGCI&S, Kolkata organised a Workshop on 26.09.2019 for sensitizing the exporters/importers regarding trade data improvement. Ms. Rupa Dutta, Economic Advisor, DOC, Smt. Anindita SenGupta, Additional DGFT, Kolkata & other senior officers from DOC and o/o DGFT were present at the workshop. Mr. Niotpal Biswas, RD and Mr Amit Pal, COA Member represented the Council at this important meeting.

6.34. Meeting to discuss how to leverage reduction in Corporate Tax announced by M/o Finance for the growth of Chemical & Petrochemical Sector, and to seek suggestions on proposed new Foreign Trade Policy, New Delhi – September 30, 2019

At a meeting was chaired by Secretary (C & PC), while all stakeholders present welcomed the reduction in Corporate Tax, there was a request to address the issue of MAT (Minimum Alternate Tax).

Regarding the Foreign Trade Policy (FTP), CPMA suggested reduction in Value Addition for polymers from 15% to 5% under Advance Authorization Scheme.

The Council raised the issue of FTAs, particularly the India ASEAN FTA, and the need for BIS Standards for finished plastic products to prevent the import of sub-standard plastic goods into the country.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.35. Appointment with Joint Secretary (TRU), Department of Revenue, Ministry of Finance, New Delhi - October 10, 2019

A meeting was held with Mr. G.D. Lohani, Joint Secretary (TRU), Department of Revenue, Ministry of Finance by Council Vice Chairman, Mr. Arvind Goenka to discuss the issue of increasing the Customs Duty on PVC Sheeting from 10% to 15%.

The issue arose due to the fact that while the Customs Duty on PVC Floor covering had been increased to 15% in the recent budget, a corresponding increase in duty did not take place in case of PVC Sheeting. Since PVC Flooring and PVC Sheeting look similar, imports of PVC Flooring were taking place under the garb of PVC Sheeting at lower Customs Duty resulting in loss of revenue to the Government, and hurting domestic manufacturers of PVC Floor covering.

The Joint Secretary assured him that they would investigate the matter. Council has also submitted a prebudget proposal to the Department of Commerce in this regard.

Mr. Arvind Goenka, Vice Chairman, Mr. Kamal Dayal, Vice President, RMG Poly Vinyl India Ltd., and Mr. Sanjiv R. Dewan, Regional Director attended the above meeting.

6.35. Meeting with Additional DGFT regarding Fixing of Minimum Export Price of Human Hair, New Delhi – October 17, 2019

The Council along with representatives from the Human Hair sector, met the Additional DGFT, Mr. Vijay Kumar, to discuss fixing a Minimum Export Price for Non-Remy Hair to curb under-invoicing and smuggling of the same.

The Additional DGFT requested the representatives for a detailed representation in this regard, and to furnish some benchmark price available on the public domain to enable DGFT to fix a minimum export price.

Mr. Sunil Eamani, Mr. Steven, and Mr. Solanki from the Human hair sector, along with Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.36. Interactive Session on Trade & Business Opportunities between India & Japan, New Delhi – October 18, 2019

The main objective of the interactive session, organized by FIEO, was to discuss the emerging opportunities between India and Japan and to enhance trade and economic ties between the two countries. FIEO signed an MOU with Japan India Industry Promotion Association (JIIPA) at this session.

JIIPA (www.npo-jiipa.org) is a Tokyo based NPO approved by Tokyo Metropolitan Government, to promote trade between India and Japan. It provides business consultation and strategy for business development for companies in Indian and Japanese market, marketing opportunities, advertising support, sales promotion by introducing the most appropriate channel of wholesaler / distributor / dealer/retailer chain. JIIPA has worked with CII, FICCI and AEPC in the past. Their office in India is based in New Delhi, and Mr. Karan Magu who is their Associate Director in Delhi, had a detailed discussion with our former Chairman, Mr. Manoj Agarwal. The Council's Regional Director also had a brief discussion with Mr. Karan Magu and enquired how JIIPA could assist with delegations to Japan. Mr. Magu suggested that the Council could organize B to B meetings, translation services etc. for delegations visiting Japan.

Mr. Sanjay Chadha, Additional Secretary, DOC, Mr. Kamal Saraf, President, FIEO, Mr. Shigemaro Yasui, Chairman, JIIPA, along with our Former Chairman, Mr. Manoj Agarwal, were some of the dignitaries present at the interactive session.

6.37. Meeting with all EPCs to discuss Export Performance, New Delhi – October 24, 2019

The following points were raised by our Council at a meeting chaired by the Commerce Secretary (CS) with all EPCs to discuss the export performance and issues hampering growth in exports. The CS was informed that the decline in exports in the plastics sector for the period April to September 2019, was mainly on account of the negative growth in plastic raw materials that was impacted by the decline in international prices of plastic raw materials resulting in lower value realization in dollar terms.

Some of the major issues, highlighted were as below:

- Issue of FTAs, particularly with ASEAN, which has resulted in an inverted duty structure for some plastic items such as polyester films and PVC flooring and sheeting.
- Issue of the FIBC sector for which the MEIS of 4% has been withdrawn, and the sector has not been included under the ROSCTL scheme either.

- 65TH ANNUAL REPORT
- PSU companies such as IOCL should be requested to supply plastic raw material to the MSME units on deemed export basis, so that MSME units engaged in exports have easier access to raw material.
- The Government should set a clear definition of Single use plastics, and all the items that would be covered under it to remove the uncertainty being faced by this sector. BIS standards on plastic raw materials should not be insisted upon, since these are big companies, and are following international standards. Instead, there should be BIS standards on finished plastic products to discourage the import of sub-standard finished plastic goods into the country.
- EPCG Scheme should be liberalized, and instead of insisting upon maintaining average export obligation, only the norm of exporting 6 times the duty saved should be insisted upon. Certain ICDs, such as the ICD in Malanpur (M.P.) have been insisting upon 100% inspection of export consignments, thus causing huge delay and expenses to some of our exporters.

While the CS noted these issues, and said they would be investigated, he advised all EPCs to request exporters to push their exports that are in the pipeline, by trying to ship out their orders a month or two in advance. From the Government's perspective, he said it was much needed to arrest the overall decline in exports and meet the target for the current financial year.

Mr. Arvind Goenka, Vice Chairman, and Mr. Sanjiv R. Dewan, Regional Director, represented the Council at the meeting.

6.38. Interactive Session with stakeholders to Enhance Competitiveness of Indian Industry, New Delhi – October 28, 2019

An Interactive Session with stakeholders to Enhance Competitiveness of Indian Industry was chaired by the Hon'ble Minister for Commerce & Industry, Shri Piyush Goyal. The meeting was organized by DPIIT, and was attended by some of the major industry leaders, such as the M.D. of Tata Steel, Mr. Sajjan Jindal, M.D. Jindal Steel, Mr. A.S. Mehta, MD, JK Paper, MD, Escorts Ltd, Group Head, Apollo Tyres Ltd., etc.

The main agenda of the meeting was to discuss how to enhance the global competitiveness of Indian industry. The focus was on internal taxes (State and Centre levies) impacting export competitiveness given the fact that the current schemes such as MEIS and even EPCG were most likely to go as they were incompatible at the WTO, the emphasis was to seek urgent inputs from the industry regarding the internal taxes, i.e the State and Central levies as informed by the Minister.

The reimbursement of taxes by the State and Centre were compatible with the WTO, and it was imperative that the industry furnished details of taxes levied on products exported by them. The Minister emphasized that this was required to be done on an urgent basis.

Additionally, the Minister also stressed that the industry needs to compile all the Non-Tariff Barriers, or any other unfair practices being adopted by any country, which must be brought to the notice of his Ministry. An issue highlighted here was the restrictive trade practices adopted by some countries, wherein Indian companies were not allowed to bid for tenders. The Minister stated that if any country adopts such a practice, then India would also retaliate in similar manner and prevent companies from that particular country to bid for tenders in India, under the principle of reciprocity of the "Make in India" programme.

The Minister also informed that around 21,000 acres of land was available with the Government at industrial parks/corridors in addition to land held by several PSUs that are ineffectively used. The industry could hence suggest ideas for effective use of such land.

Plexconcil highlighted the following issues at the meeting:

- Issue of FTAs, particularly with ASEAN, which has resulted in an inverted duty structure for some plastic items.
- Issue of the FIBC sector for which the MEIS of 4% has been withdrawn, and the sector has not been included under the ROSCTL scheme either.
- EPCG Scheme to be liberalized, and instead of insisting upon maintaining average export obligation, only the norm of exporting 6 times the duty saved should be insisted upon.
- Certain ICDs, such as the ICD in Malanpur (M.P.) have been insisting upon 100% inspection of export consignments, thus causing huge delay and expenses to some of our exporters.
- The sudden surge in imports of Masterbatches from Vietnam was also highlighted and CIM was informed that the DGTR had called for a meeting on 6th November wherein representatives of CMMAI would be attending.

The Minister while taking note of the above issues, also mentioned that for the plastics industry, the Government was willing to allocate land in order to create a plastics cluster, and industry should suggest where they would need land for this purpose.

It was a meeting which lasted more than three hours, and the Minister while appreciating all those present for taking time out for being present for this important meeting, also instructed his department to check on EPCs/invitees who failed to attend, and to blacklist them for at least the next one year. He further insisted that at such forums focus only Policy and industry matters and individual company matters should not be taken up.

Regional Chairman (North) and Regional Director (North) represented our Council at the meeting.

6.39. Meeting with Mr. Anil Agarwal, Additional DGFT to discuss withdrawal of MEIS on FIBC w.e.f. 1st August, 2019, New Delhi – November 8, 2019

Regional Director, Mr. Sanjiv R. Dewan met Mr. Anil Agarwal, Additional DGFT, with regard to the MEIS withdrawal on FIBC with effect from 1st August, 2019. Mr. Agarwal said that due to budget constraints, discussions were being held at the highest level and a decision would be communicated with week. He also emphasized that data be urgently furnished to enable fixing of rates under RoDTEP.

6.40. Human Hair Association-cum-Human Hair & Hair Products Panel Meeting, Chennai – November 9, 2019

Mr. Benjamin Cherian, Panel Chairman (Human Hair & Hair Products Panel, Plexconcil) and President, Human Hair and Hair Products Manufacturers and Exporters Association of India (HHHPMEAI), convened this meeting with members of the Human Hair Association on Saturday, 09th November, 2019, at the Presidency Club, Chennai.

Mr. Cherian briefed members on the steps taken by the Association with support and assistance from Plexconcil in the past several years to represent and lobby for the ban on export of goli/chutti hair, and for preventing the under-invoicing and smuggling of human hair to Myanmar and China by unscrupulous traders, including Myanmar and Chinese nationals (which has hit genuine exporters and also resulted in major loss of jobs), through various representations made to the Commerce Secretary and the Zonal Additional DGFT (through Plexconcil), and various personal visits to the Ministry, and the recommendations obtained as a result of such an effort.

During the discussion on next steps, Mr. Cherian read out the latest office memorandum from Commerce Ministry, New Delhi, addressed to DGFT with copy to our Association regarding the ban of Goli/Chutti. He further added that a G.O. was expected to be issued within next 10 days.

Mr. Gupta and Mr. Srinivasa Rao briefed all of their meetings with DGFT officials and insisted that the industry must fight for total ban of Goli/Chutti, as it was critical to livelihood of trade members.

The Panel was to make suggestions/recommendations to Plexconcil on export marketing support by identifying and recommending appropriate International Trade Fairs for the sector to participate in for export growth.

Mr. Jaswanth Soundarapandian, Regional Director, and Mr. R. Dayanidhi, Assistant Director, attended the meeting.

6.41. Meeting with stakeholders to discuss Scheme for Setting up of Plastic Parks, New Delhi – November 19, 2019

The meeting was held under the chairmanship of Secretary (C&PC), to discuss additional points for framing up new Guidelines relating to the Scheme for setting up of Plastic Parks. The Secretary said that the progress of the four existing plastic parks, had so far been disappointing, and one of the factors affecting the success of this Scheme was the poor location of these plastic parks. He informed said the Government had already spent more than Rs.100 crores on this Scheme, and the meeting had been convened to essentially debate on the interventions required for the success of this Scheme.

During the course of the meeting, it was observed, that only one unit was currently operational in the plastic park at Tamot, Madhya Pradesh, out of the four existing plastic parks. It was also observed that an assured supply of raw materials was essential for plastic parks to succeed. The representative from AIFTMA, stated that each state needs have a clear policy on plastics, particularly regarding single use plastics, EPR and plastic waste management, to remove the uncertainty amongst plastic processors on these issues. Any fresh investments by plastic units would only take place, if such uncertainties were addressed.

It was finally concluded that amendments were required in the existing plastic parks policy, and a committee should be formed to suggest amendments to the same. The Committee should include prominent plastic associations, FICCI, CIPET, and associations involved in plastic recycling.

Mr. Arvind Goenka, Vice Chairman& Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.42. Meeting regarding Future Vision and Research in Chemicals & Petrochemicals Sector, New Delhi – November 20, 2019

The meeting was held under the chairmanship of Secretary (C&PC), to discuss the future direction for undertaking research in the Chemical and Petrochemical sector and constitute a coordination committee to decide the Terms of Reference for the same. It was felt that while there was a lot of good work being done in R&D and innovation in educational institutions and research institutes, there was little engagement between them and the industry. As a result, there were a lot of ideas, which were not commercially realized, resulting in missed opportunities for industry.

During the meeting, a decision was made to have a web portal, where all the research institutes, laboratories etc. could upload their research. It was also suggested that the requirements of the industry are identified, and accordingly, the research is designed to satisfy the needs of the industry.

Plexconcil highlighted the fact that the plastics processing industry was in dire need of technology upgradation to increase export competitiveness and boost export of finished plastic goods. Research should be directed towards introducing newer technology, which would cut down production costs, and enable the industry to be more competitive in the international market. Council also highlighted the need for having BIS standards for finished plastic goods, in order to prevent import of sub-standard plastic goods into the country.

Mr. Arvind Goenka, Vice Chairman & Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.43. Meeting to interact with plastic industry to address their concern of facing issues in getting land, New Delhi – November 29, 2019

In a meeting chaired by Additional Secretary, DPIIT, the Joint Secretary (C&PC), talked about the Plastics Parks Scheme of the Government, and mentioned that there were currently six plastic parks that had been set up, out of which one was complete in all aspects. However, he informed that the Scheme had not really taken off, and only one unit was operational in the park.

It was mentioned that the Delhi Mumbai Industrial Corridor Development Corporation (DMICDC) had informed about land availability in the industrial clusters under the DMIC project at four cities. These were the Dholera Industrial city in Dholera, Gujarat, Aurangabad Industrial city, in Aurangabad, Vikram Udyogpuri, in Ujjain, Madhya Pradesh, and Integrated Industrial Township Greater Noida, at Greater Noida, Uttar Pradesh. The area available as part of industrial land use in these cities ranged from 332 acres in Greater Noida, U.P. to 1759 acres in Dholera, Gujarat. However, the cost of land varied from Rs. 1980/sqm in Ujjain to Rs. 5100/sqm in Greater Noida, which was felt to be too high. It was suggested that the Government could instead lease out the land at a reasonable rent, which would encourage plastic processors to set up their units. Our Council also suggested some other facilities that should be made available at these industrial areas, in order to attract plastic processors there.

The suggestions made were as below:

- Infrastructure should include accommodation for employees, Warehousing space for raw materials and finished goods, a Common effluent treatment plant, a Plastic Waste recycling unit and subsidies by the government.
- Direct Power from the grid should be made available at a reasonable rate. For units which opt for solar energy the government should give some additional incentives to encourage use of the same.
- We already have interest subvention for exports. However, interest subvention should also be there for finance raised for setting up the unit at the plastic parks.
- Dr. Nayak from CIPET also suggested that CIPET would have a skill development center and a testing facility at these industrial areas.
- The Council also suggested that land should be close to the port, in order to minimize logistics cost and make plastic exports more competitive.

Accordingly, it was decided to develop the industrial land available at Dholera, Gujarat, for the plastics sector. It was decided to initially allocate around 200 acres land and have most of the common facilities suggested above. Land at a reasonable rent, power directly from the grid, and interest subvention for setting up plastic processing units, would be offered as mentioned by the Additional Secretary, apart from the common facilities suggested above.

Mr. Arvind Goenka, Vice Chairman. Mr. Pranay Kumar, M/s Vasudhaecofriends Projects Pvt. Ltd., and Mr. Sanjiv R. Dewan, Regional Director, represented the Council at the meeting.

6.44. Preparatory meeting on India-Nigeria Joint Trade Committee (JTC) Meeting, New Delhi – December 9, 2019

A meeting was chaired by Director, FT (Africa) Division to finalize the agenda for the upcoming India-Nigeria Joint Trade Committee (JTC) meeting.

The Council raised the issue about the mandatory inspection certificate, known as SONCAP Certificate, which is insisted upon by the Nigerian authority. The minimum cost of this certificate is US\$ 250/- and adds to the cost of the Indian exporter. Council requested that this issue be taken up during the fourth coming JTC meeting.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.45. Press Conference in Delhi on Interpack Exhibition to be held between May 7 – 13, 2020 at Dusseldorf, Germany, New Delhi – December 12, 2019

Messe Düsseldorf, the organizers of Interpack organized a press conference in Delhi to welcome the Indian Packaging and Processing Industry/Media to the world's most important trade fair in this segment.

Plexconcil, being the India Pavilion organizer at Interpack in Düsseldorf, was invited to apprise the Industry and the media about its activities and the Indian pavilion at Interpack. The Council's Vice Chairman, Mr. Arvind Goenka spoke about the various Council activities, benefits of becoming a member of the Council, and the financial subsidy available from the Council under the MAI Scheme of the Department of Commerce for participation at trade fairs and Buyer-Seller Meets abroad where the Council organizes participation for Indian exhibitors. He encouraged exporters from the packaging sector to participate at Interpack through the Council to avail the benefits available under the MAI Scheme.

Other speakers at the event were Mr. Bernd Jablonowski, Global Portfolio Director, Processing and Packaging & Board of Director, Messe Düsseldorf India, and Mr. Thomas Schlitt, Managing Director, Messe Düsseldorf India.

Mr. Arvind Goenka, Vice Chairman & Mr. Sanjiv R. Dewan, Regional Director represented the Council at the Press Conference.

6.46. Meeting on EFTA Rules of Origin, New Delhi – December 17, 2019

A meeting chaired by Mr. Bipin Menon, Additional DGFT, was held to discuss the possible Rules of Origin (ROO) on Chemicals, wood, paper and plastics, with EFTA, which is a grouping of 4 countries, namely Iceland, Leichenstein, Norway and Switzerland.

The discussion focused on looking at the entire manufacturing process of the above-mentioned products, including the value addition and inputs used in them. It was emphasized at the meeting that the criteria for ROO in general would need to be either CTH/CTSH or a minimum Value Addition, but not both.

For value added plastic items our Council emphasized that the ROO criteria should be both CTSH and minimum 40% value addition, keeping in mind the nature of our domestic plastic processing industry, and the threat of surge in imports of finished plastic products into the country. The Council also requested that comments from DCPC be sought in this regard.

Mr. Sanjiv R. Dewan, Regional Director, represented the Council at the meeting.

6.47. Meeting with DGFT official to discuss issues of Human Hair, New Delhi – December 20, 2019

The Council arranged a meeting of member exporters from the Human Hair sector, with Mr. Vijay Kumar, Additional DGFT to discuss the issue of illegal trade and under- invoicing that is widely prevalent in Human Hair exports.

Mr. Vijay Kumar advised the exporters to make a representation supported by relevant data to enable the DGFT to fix a Minimum Export Price (MEP) for export of Non-Remy Human Hair. According to him, this was the only practical way to curb both illegal trade and under-invoicing as it was unlikely that any sort of restrictions would be imposed by DGFT besides fixing an MEP. Exporters present agreed to make a representation accordingly.

Mr. Sunil Eamani from M/s. Indus Hair Extensions and Mr. Prem Solanki from M/s. DCS International, along with Mr. Sanjiv R. Dewan, Regional Director, were present at the meeting.

6.48. Inter-Ministerial Meeting for negotiating trade agreement with Peru covering trade in Goods, Services & Investment, New Delhi – December 20, 2019

A meeting was held under the Chairmanship of Shri Shyamal Misra, Joint Secretary on offers to be made to Peru by India on their Wish List. It was informed that Peru has shared a revised Wish List of 3700 tariff lines at 8-digit HS Code.

Our Council had earlier provided inputs on 184 lines pertaining to plastics out of the entire wish list of Peru and offered concessions on only 11 tariff lines falling under Chapter 39. The Council was requested to update their views on the 184 tariff lines and see if there were any other lines which were left behind and provide inputs on the same.

The Council was also requested to look into the possibility of providing concessions on additional tariff lines for import from Peru, since concessions being sought from Peru were on 111 tariff lines in the plastics sector, while concessions being offered to Peru were only on 11 tariff lines of the 184 tariff lines in plastics.

Mr. Sanjiv R. Dewan. Regional Director represented the Council at the meeting.

6.49. Stakeholder Consultation for India – EU BTIA & India-UK Trade, New Delhi – December 27, 2019

The Stakeholder consultation was chaired by Joint Secretary, FT(Europe) Division in anticipation of resumption of EU (ex – UK) negotiations and the possibility of separate discussions with UK, post Brexit.

JS advised all concerned stakeholders to inform the Ministry about tariff lines where they seek market access, as well as those tariff lines where we are unwilling to give market access to the EU & U.K. In addition to this, information was also required to be furnished on the Non – Tariff Barriers and Regulatory issues being faced in the EU and UK. JS emphasized that tariff lines and issues with the U.K. need to be furnished first and were required at the earliest.

Mr. Sanjiv R. Dewan. Regional Director represented the Council at the meeting.

6.50. Brainstorming session to discuss steps for efficient implementation of Start-Up Vision 2024, New Delhi - December 31, 2019

The meeting was held under the Chairmanship of Joint Secretary (PC) to brainstorm ways and methods to encourage the entrepreneurs to establish/set up their start – ups in the Plastic Parks by the State Governments with grant - in - aid funding by the Government of India. This session aimed to devise a mechanism to help them by providing end-to-end solutions through various GOI and State Govt. schemes, raw material, machinery, technology, skilled manpower & market for their finished product.

Some of the suggestions that emerged from the brainstorming session were:

- Make land available on leased rent at nominal rates at the Plastic parks.
- Assured power supply at competitive rates
- Raw material at cheaper rate with credit facility can be a big incentive in a plastic park Infrastructure and utilities should be provided by the Central Govt.
- The Council suggested to make exports attractive, facilities at the port need to be seen and how well it is serviced by the major shipping lines to ensure deliveries within stipulated deadlines.

Mr. Arvind Goenka, Vice Chairman and Mr. Sanjiv R. Dewan. Regional Director represented the Council at the meeting.

6.51. Meeting for proposed regulation of Single Use Plastics and other polymers with Industry Associations, New Delhi – January 2, 2020

The meeting was chaired by Mr. Raghavendra Rao, IAS, Secretary (C&PC) and was attended by Plexconcil Vice Chairman and the Regional Director (North). Key suggestions included increase in the thickness of plastic carry bags to 100 or 125 microns, have a minimum weight for plastic disposable cutlery and increase the GSM for non-woven carry bags, rather than banning them. It was also emphasized that the Regulations should be uniform across the country, rather than each State having its own regulations.

Mr. Arvind Goenka, Vice Chairman and Mr. Sanjiv R. Dewan. Regional Director represented the Council at the meeting.

6.52. Regional Advisory Committee (RAC) Meeting of CIPET, Murthal, Haryana held in Chandigarh, -January 8, 2020

This was the first meeting of the RAC, and was chaired by Mr. Ankur Gupta, IAS, Principal Secretary to Government of Haryana. The meeting discussed the upgradation and expansion of CIPET Murthal's facilities, including its testing facilities to service the plastics industry more effectively.

Regional Director (North), briefed the Principal Secretary, about how CIPET could play a far greater role to boost plastic exports, based on inputs given by the Vice Chairman. Some of the important suggestions



given to the Principal Secretary included upgrading the testing facilities of CIPET to test as per International standards, and more importantly ensure test certificates are acceptable internationally.

It was also stressed upon that certain tests required for supply of specific plastic items to Indian Railways were conducted abroad as the testing facility was not available within the country. It was requested that CIPET should have such testing facilities and that it needs to play a greater role in upgrading the technical skills of personnel employed in the plastics industry. A formal paper highlighting these points prepared by the Vice Chairman was handed over to the Principal Secretary.

6.53. ASCEND KERALA 2020 – Global Investors Summit, Chennai – January 9 - 10, 2020

Mr. Ruban Hobday, Regional Director attended the ASCEND KERALA 2020 which was inaugurated by Shri. P. Vijayan, Hon'ble Chief Minister of Kerala. He also attended the Conclave and the seminar on "Petrochemicals" addressed by the State Govt. Officials. The Regional Director also had fruitful discussions regarding the Council's involvement in State Export Initiatives with the following State Govt. Officials on the side-lines of the event:

- Dr. K. Ellangovan IAS, Principal Secretary II
- Shri. Sanjay Garg IAS, Principal Secretary II
- Shri Tom Jose, IAS, Chief Secretary Govt. of Kerala & Chairman KINFRA
- Mr. K.M Harilal, ITS Joint DGFT
- Shri. S. Santhosh, CEO, Kerala Bureau of Industrial Promotion (K-BIP)

The Regional Director met some top exporters and Committee Members of the Kerala Plastic Manufacturers Association and had detailed discussion on Council's activity in Kerala. He met Mr. Ibrahim - Member - Aluva Plastic Consortium and discussed his letter sent to MSME Kerala and the subsequent discussion with Plexconcil. He was apprised of the Council's role and the benefits that his organization could avail.

6.54. Meeting on 1st Session of India Norway Dialogue on Trade & Investment (DTI), New Delhi – January 16, 2020

The meeting was chaired by the Joint Secretary, Ms. Nidhi Mani Tripathi and a high-level delegation from Norway, including Norway's Ambassador to India were present at the meeting. The meeting aimed to enhance the bilateral engagement in trade and investment between the two countries in various sectors such as Renewable Energy, Services, Aquaculture & Fisheries, Chemicals & Petrochemicals etc. An MOU was signed between the two sides at the end of the meeting.

Regarding Plexconcil, the Norwegian delegation was requested to share their expertise/experience in dealing with Single use plastics and conversion of plastic waste to energy. The Norwegians said they had numerous plants operating in their country which convert plastic waste to energy.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.55. Meeting to finalize the report on Technological Upgradation Fund Scheme (TUFS) for plastic processing industry, New Delhi – February 3, 2020

A meeting chaired by the Secretary (C&PC) was held to discuss the TUFS proposal for the plastics sector with the aim to arrive at a broad consensus amongst the concerned stakeholders with regarding the list of machinery circulated by DG, AIPMA, vide his email of 5th January, 2020.



Discussions went off well but there were some differences in opinion between the machine manufacturer Milacron and AIPMA. The Secretary requested both parties to resolve the matter, reach a consensus and submit a final list by 15th February 2020.

Mr. Arvind Goenka, Vice Chairman & Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.56. Meeting on 1st Session of India Norway Dialogue on Trade & Investment (DTI), New Delhi – January 16, 2020

The meeting was chaired by the Joint Secretary, Ms. Nidhi Mani Tripathi and a high-level delegation from Norway, including Norway's Ambassador to India were present at the meeting. The meeting aimed to enhance the bilateral engagement in trade and investment between the two countries in various sectors such as Renewable Energy, Services, Aquaculture & Fisheries, Chemicals & Petrochemicals etc. An MOU was signed between the two sides at the end of the meeting.

Regarding Plexconcil, the Norwegian delegation was requested to share their expertise/experience in dealing with Single use plastics and conversion of plastic waste to energy. The Norwegians said they had numerous plants operating in their country which convert plastic waste to energy.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.57. Meeting to finalize the report on Technological Upgradation Fund Scheme (TUFS) for plastic processing industry, New Delhi – February 3, 2020

A meeting chaired by the Secretary (C&PC) was held to discuss the TUFS proposal for the plastics sector with the aim to arrive at a broad consensus amongst the concerned stakeholders with regarding the list of machinery circulated by DG, AIPMA, vide his email of 5th January, 2020.

Discussions went off well but there were some differences in opinion between the machine manufacturer Milacron and AIPMA. The Secretary requested both parties to resolve the matter, reach a consensus and submit a final list by 15th February 2020.

Mr. Arvind Goenka, Vice Chairman & Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.58. Brainstorming session to discuss Perspective Plan issued by EIL and to formulate a new policy to curb Import of Plastic/ Petrochemicals, New Delhi – February 3, 2020

The meeting chaired by Secretary (C&PC) was held to discuss the Perspective Plan issued by EIL and to deliberate the points/ issues to be included for formulating a new policy to curb Import of Plastic/ Petrochemicals.

EIL made a detailed presentation on their report "Enhancing Petrochemical Production in India". It was a draft report, prepared jointly by EIL and IOCL. The draft report was prepared with the core objective that India should have sufficient capacity to meet its domestic demand of polymers, and not necessarily be an exporter of polymers.

The presentation highlighted the projected demand supply gap for some key polymers in the long term, particularly PE, PP and PVC. In the short term, it was highlighted that PVC had the highest demand supply gap, followed by PE and PP.

A key point highlighted during the meeting was that more crude would be available for the Chemical and Petrochemical industry, once Electric Vehicles begin to gain market share in the country. It was also said that while India currently faced a shortage in polymers, globally there is a surplus of polymers.

The Secretary sought inputs from all the stakeholders on the draft report within two weeks' time. He also requested that while the draft report would be shared amongst the concerned stakeholders for inputs, it should not be circulated widely, as it should not come into the public domain at the draft stage.

Mr. Sanjiv R. Dewan, Regional Director, Mr. Kamal Dayal, V.P., Premier Polyfilms represented the Council at the meeting.

6.59. Meeting to discuss Export & Import issues with East Asia, New Delhi – February 14, 2020

The meeting chaired by Dr. Anup Wadhawan, IAS Commerce Secretary focused on the challenges and opportunities that have arisen due to the disruption caused in the Chinese economy by the Corona virus.

The CS requested all Councils/ trade bodies present to be in touch with their members and determine the following:

- The extent to which exports to China would be affected due to the disruption in the Chinese economy. The CS requested that this should be closely monitored and if exports to China are impacted, it should be brought to the notice of DOC.
- Exploit the opportunity to enhance our exports to markets which are dominated by China, as a result of the disruption in the Chinese economy. Encourage manufacturers of product lines where Chinese exports are dominant to ramp up their production capacity and increase their exports to markets dominated by China.

The CS also stressed that information should be shared/sought from member exporters only and not widely publicized in general, as a certain degree of confidentiality needed to be maintained on the matter.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.60. Meeting regarding Increasing the publicity of Rules of Origin and PMLA violations to deter the wrongdoers, New Delhi – February 24, 2020

The meeting was chaired by Shri A. Bipin Menon, Addl. DGFT, Department of Commerce during which he stressed that EPCs need to organize outreach programmes for their members to create awareness amongst them with regard to Rules of Origin(ROO). An official from DOC could also be involved in this exercise. The exercise would involve providing inputs to members with regard to the ROO for each of the FTA/PTA that India has engaged in with various countries/regions, with adequate justification for the ROO specified, and seek inputs from members where they may know that ROO by the FTA/PTA partner country is being violated, with regard to imports into the country.

Mr. Menon also stressed upon exploiting the opportunity due to the disruption in Chinese economy, and organizing BSMs with countries where China has a dominant share. He suggested review and developing alternate supply sources, where these have been affected due to China.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.61. Discussion on Disruptions in Chemicals & Petrochemicals Sector in view of Corona virus infliction and consequent shutdown of vast segments of Chinese industry, New Delhi – March 4, 2020

The meeting was chaired by Secretary (C&PC) and the following points were stressed upon:

- Sensitizing members/stakeholders about the current situation and exploring alternate sources of supply where disruptions have been caused by China.
- Exploring possibility of increasing our share of exports to countries where China is a dominant supplier.
- Inform DCPC of the critical chemicals and petrochemicals that are required to be imported to maintain an inventory of the same.
- Inform DCPC about those production units whose licenses have been pending for enhancement of production capacity, due to clearance pending with MOEF and could be fast tracked for items where we stand to benefit due to the Corona virus.

Council raised the following major issues at the meeting:

- Masterbatch sector would be affected due to disruption in certain raw materials required by this sector, where China is a major supplier.
- DCPC was requested to pursue the issue of Single Use Plastics (SUP) with MOEF so that a policy on the same is announced without further delay.
- Hike in sea freight rates, and the major imbalance in container availability due to the disruption in Chinese economy. The Secretary requested a note be furnished in this regard.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.62. Meeting to discuss issues regarding India- Egypt Bilateral Trade, New Delhi – March 4, 2020

The meeting was chaired by Jt. Director, Mr. Praveen Kumar with stakeholders to discuss NTBs being faced regarding exports to Egypt. The Council highlighted the following NTB at the meeting:

Egypt has a requirement of mandatory pre-shipment inspection wherein any consignment being exported to Egypt must have a pre-shipment inspection certificate. This certificate can be issued only by companies registered with GOEIC (General Organization for Export and Import Control) under the Ministry of Trade and Industry, Egypt. While companies such as TUV, Austria are registered with GOEIC, we suggested that our EIC should also be registered with GOEIC, and a request could be made with the Egyptian authority in this regard.

Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

6.63. Export Review Meeting with EPCs, New Delhi – March 9, 2020

A meeting was chaired by the Joint Secretary, Shri S. Suresh Kumar to review the export performance of EPCs under his Division, and to discuss measures to be taken to double exports by 2024-25.

The following points were highlighted by our Council:

1. The negative growth in the plastics sector was mainly due to the negative growth in plastic raw materials, which accounts for more than 35% of the total plastic exports from the country. This was attributed to the lower price realization given the depressed prices of polymers in the international market and hence a lower overall value realization for exports made. The JS was also informed that the prices of polymers/plastic raw materials are directly linked to the international price of crude oil.

- 2. As a part of the measures to double exports by 2024-25, the issue regarding inadequate MAI support was highlighted. The Council said that the MAI support extended was much lower than 65%, as stipulated in the MAI guidelines, and the condition of minimum 30 to 50 exhibitors' participation in a trade fair needs to be relaxed. The JS was also informed of the various issues of each product panel in the plastics sector, that had already been shared with the Division, and needed urgent attention. The JS emphasized focus on the LAC region, as around 25% to 30% of the export to this region is from China, and EPCs should look at tapping this opportunity due to the disruption in the Chinese economy.
- 3. Regarding the expansion of membership base and active involvement of members, it was mentioned that about 14 membership outreach programmes/Export awareness seminars had already been conducted in the current financial year in the industrial towns/cities where the plastic processors are based. These programmes were done in association with the local plastic associations. Speakers at the seminars included officials from DGFT, ECGC, Ministry of MSME etc. Also, for the active involvement of members, the Council had created WhatsApp groups of members in each region and was also in the process of developing a mobile app for active engagement of members.

Mr. Sribash Dasmohapatra, Executive Director, and Mr. Sanjiv R. Dewan, Regional Director, represented the Council at the meeting.

6.64. Meeting to discuss Global Disruptions in Supply Chains and their impact on India, New Delhi – March 12, 2020

A meeting chaired by the MOS, Shri. Som Parkash was held to seek updates on global disruptions in the supply chain due to the Corona Virus, and its impact on India.

While each EPC/trade body spoke about the disruptions in their sector, and the support required from the Government, Vice Chairman and Regional Chairman highlighted the following with regard to the plastics sector:

- The major imbalance in container availability due to the disruption in the Chinese economy, leading to a steep hike in sea freight rates. The Vice Chairman requested that a suitable directive be issued to Shipping Lines to which the Commerce Secretary responded that while freight rates are largely market determined, they would nevertheless take up the issue with the Ministry of Shipping and consider what best could be done.
- Major imports from China in the plastics sector include finished goods, and the disruption in the Chinese economy would prove beneficial for the domestic plastic processing sector with the fall in imports of such products.
- Impact on import of certain raw materials for Masterbatches if the situation does not improve since China and Italy are the two main sources of supply and both were badly affected by the Corona Virus.

The Commerce Secretary (CS) enquired whether EPCs had sensitized their members, and shared information made available by some of our Missions abroad regarding opportunities that have arisen in certain product categories.

FIEO requested for easing liquidity for the MSME sector, by instructing banks to make it easier to extend credit to MSME enterprises. FIEO also requested that ECGC cover for exports to be enhanced.

MOS, in his closing remarks, stated that extra efforts need to be put in by all trade bodies to manage the situation, and assured that the Government would extend all the support required to the exporting community.

Mr. Arvind Goenka, Vice Chairman, Mr. Vikram Bhadauria, Regional Chairman & Mr. Sanjiv R. Dewan, Regional Director represented the Council at the meeting.

1. SIGNIFICANT ACCOUNTING POLICIES

a) GENERAL

The financial statements are prepared undergoing concern assumption based on the historical cost convention and by applying applicable Accounting Standards. The preparation of financial statements is in conformity with generally accepted accounting principles as applicable in India (Indian GAAP). The company follows mercantile system of accounting and recognizes income and expenses on accrual basis unless stated otherwise in the notes and except the items with significant uncertainties.

b) USE OF ESTIMATES AND JUDGEMENT

The preparation of financial statement in conformity with accounting standard requires the Management to make estimates, judgments and assumptions. These estimates, judgments and assumptions affects the application of accounting policies and the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of financial statement and reported amounts of revenue and expenses during the period. Accounting estimates could change from period to period. Actual result could differ from those estimates. As soon as the Management is aware of the changes, appropriate changes in estimates are made. The effects of such changes are reflected in the period in which such changes are made and, if material, their effects are disclosed in the notes to financial statement.

c) PROPERTY PLANT AND EQUIPMENT

Property Plant and Equipment are carried at cost net of input credit, less accumulated depreciation and impairment loss, if any. All costs, including financial costs till commencement of commercial production / date of use of assets and also includes changes on account of foreign exchange

- III. Grant under MDA initiative for the benefit of Individual member exporters for the export promotion is disbursed on the bases of guidelines prescribed on this behalf only after the same is sanctioned and received form the Government. Disbursal that remains unpaid to individual exporters till the date of financial statement is reflected ascurrent liability. However, any surplus not applied for the purpose is to be refunded to the Government of India. The accounting for such grant in the books of the company is done only on the bases of amount sanctioned and received form the Government.
- IV. Grant received by the Council for the specific studies/Project/Events approved by the Government, tillthe time such activities or objectives are achieved carried forward as liability. The amount spent on the projects as per the guidelines includes appropriate allocation of the administrative cost incurred by the council on the project if so mandated underguidelines prescribed for the purpose. However, any surplus not applied for the purpose is to be refunded to the Government of India along with interest.

g) RETIREMENT BENEFITS:

- (a) Council's Contribution to Employee's Provident Fund maintained under the Employee's Provident Fund Scheme run by the Government ischarged to Income and ExpenditureAccount.
- (b) The Employees Gratuity Liability is funded with the Life Insurance Corporation of India under Group Gratuityscheme.
- (c) Leave Encashment Benefits as applicable to permanent employees are provided for on accrual basis as at the year-end as per the Council's rules. However, the said liability is not backed by specific investment for the purpose.

h) TRANSACTIONS IN FOREIGNCURRENCY:

Transactions in Foreign Currency are recorded at the rates of exchange in force at the time of occurrence of the transactions. The difference arising out of foreign currency fluctuations is accounted as a part of revenue or expenditure as the case may be as has occurredduring the course of theyear.

Current Assets and Current Liabilities in Foreign Currency at the yearend are stated at the rate of exchange in force as on that date and the resultant Gain/(Loss) is recognized in the Income and Expenditure Account. contracts and adjustments arising from exchange rate variations attributable to the Property, Plant and Equipment.

Intangible assets are stated at cost of acquisition and amortized over the estimated useful life of such assets.

d) DEPRECIATION AND AMORTISATION:

Depreciation on Property Plant and Equipment is provided as per the Guidance provided in Sch II of The Companies Act, 2013 and on written Down Value of the Property Plant and Equipment.

In respect of additions to fixed assets during the year, depreciation is considered on prorata basis from the date such assets are put to use. Assets costing Rs. 5,000 or less each are fully provided in the year of addition.

e) **REVENUE RECOGNITION:**

- The cost of Publications of the Council is charged to the Income and Expenditure Account in the year of when expenses are incurred. The Income in respect of the such publication is taken into account as and when their sales are affected. The movement of Publications is controlled under the overall supervision of the Executive Director.
- 2) Membership fees is accounted as and when renewal subscriptions are received in terms of the rules governing the membership. Membership from new members accounted at the time when the admission of such new member/s are approved in terms of the procedure laid out for the purpose.
- Prepaid expenses are provided when the individual value of such expenses are Rs. 5,000 and more.

f) GOVERNMENT GRANT:

- 1. Grants received from Government in respect of coded activities is credited to Income and Expenditure Account on the bases of fair estimate for the same as provided by the management, on the bases of the applicable criteria prescribed by the Government for the same.
- II. Grants received for acquiring the specific fixed assets, are reduced from the cost of such assets and or at a nominal value as the case may be.

- 2.3 There are no dues which are overdue to Micro, Small and Medium Enterprises as per MSME Act,2006 as at the year- end. The company has not paid interest to such small scale or ancillary industry.
- 2.4 Pursuant to the approval by the Finance Division of the Department of Commerce, Government of India for grant of Marketing Development Assistance (MDA) to individual exporters under certain eligible schemes, the Council has received from the Ministry of Commerce Rs. Nil (P.Y. Rs. 14,84,963 /-) and Rs. Nil (P. Y. Rs. 15,09,499 /-) is reimbursed to the members during the year.
- 2.5 The pending disbursal to the eligible Individual exporters under various scheme of Government of India as on 31st March, 2020 amounting to Rs. 2,86,52,447 /- = (P.Y. Rs. 2,68,63,250 /-) is being disclosed as 'Amount due to Members' under the head Current Liabilities in Schedule 2 A.
- 2.6 The participation in eligible events under the Market Access Initiatives (MAI) of Government of India is approved on case to case bases. Accordingly, an amount of Rs. 4,52,10,348 /- (P.Y. Rs. 5,37,29,302 /-.) sanctioned by the Government and Utilized on the bases of the guidelines in this respect and total amount Utilized is Rs. 6,04,48,232 /-(P. Y. Rs. 5,56,97,329 /-).
- 2.7 Company is a charitable organization established and operating for advancement of objects of general public utility. Company is registered under Section 12 AA of Income Tax Act,1961. The provisions of tax payable as applicable under The Income Tax Act, 1961 is made on the bases of applicable provisions of Income Tax Act, 1961 and considering the past history of assessments in the case of company.
- 2.8 The movement of publications / CD's is controlled under the overall supervision of the Secretary General. However, there is no system of maintaining inventory for the said materials and the same are charged to Income and Expenditure account. Inventory of Gift articles and promotional material are not carried forward and are expensed to income and expenditure account.
- 2.9 The recent pandemic COVID 19 has disrupted the normal activities and severally affected the businesses and human life. The company's management has assessed the situation and though the activities of the company are affected due to lockdown and general restrictions, the impact of the same will not jeopardise the Going Concern assumption for the company. Management is also of the opinion that no provision is required for impairment losses due to this situation.
- 2.10 The earnings in Foreign Currency for Activities of the Council Rs. 8,68,548 /-

j) IMPAIRMENT OF ASSETS:

Impairment loss of permanent nature in relation to the assets is recognized wherever the carrying amount of an asset is in excess of its recoverable amount and the same is recognized as an expense in statement of profit and loss and carrying amount of the asset is reduced to its recoverable amount.

k) **INVESTMENT:**

Long- term investments are carried at cost. However, provision for diminution is made to recognize a decline, other than temporary, in the value of investments, such reduction being determined and made for each investment individually. Short Term investments are carried at cost.

I) PROVISIONS, CONTIGENT LIABILITIES & CONTINGENT ASSETS:

A provision is made based on a reliable estimate when it is probable that an outflow of resources embodying economic benefits will be required to settle an obligation. Contingent Liabilities, if material, are disclosed by way of notes to accounts. Contingent assets are not recognized or disclosed in the financial statements.
